This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is found in verification process as stated above or is reported against him/her at later stage as mentioned in Government Instruction No. 52/08/2002-3GS-III dated 23.06.2022 and instruction No. 52/06/2018-2HR-III dated 05.02.2024. In case, any of the information is found incorrect or in case, the verification confirms that facts given by the candidate were not correct, then the appointment of concerned candidate(s) shall stand terminated forthwith without any further notice.
- 14. In case of any contradiction between terms & conditions of this appointment letter & statutory rules then in such a case statutory Rules of state Govt. (Govt. of Haryana) as well as of the department shall prevail.
- 15. Medical Fitness Certificate should be submitted before joining in the office of concerned DEEO when the regular appointment letter is issued.
