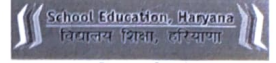

In continuation of this office order no. 2/14-2024-TGT R&A(1) dated 28.07.2024, on the recommendation of Haryana Staff Selection Commission, Panchkula conveyed vide their memo No. HSSC/Confid./Recomm/2024/442 dated 27.07.2024, the following candidates are hereby given provisional appointment in terms of O/o Chief Secretary Haryana instructions no. 52/08/2022-3GSIII dated 23.06.2022 and para 2 and 3 of instructions No. 52/06/2018-2HR III dated 05.02.2024 as Trained Graduate Teacher (TGT) Arts (HES-III) (Rest of Haryana Cadre) in the pay scale FPL-7 of schedule-I of the pay matrix of the HCS (RP) Rules 2016 plus usual allowances as admissible from time to time.

All candidates will be bound by the terms and conditions stated in their appointment letters and shall furnish an undertaking in the format provided at the time of joining.

#### **Terms and conditions: -**

1. The candidate is appointed is only on provisional basis and the regular appointment letters and place of posting will be issued later on.
2. The concerned candidate is directed to join provisionally in the office of Director General Elementary Education Haryana, Shiksha Sadan, Sector-5, Panchkula immediately.
3. The candidate shall have to take an oath of allegiance to the Constitution of India before issuance of regular appointment letter.
4. The candidate shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the

- relevant service rules and instructions of the State Government issued from time to time.
5. The appointment will be subject to the final outcome of the pending litigation, if any.
  6. The candidate shall remain on probation for a period of two years, extendable upto three years as per rules 27 of HCS (General) Rules, 2016.
  7. In the matters, not specifically mentioned in this communication, the candidate shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
  8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
  9. The candidates shall be governed by the Haryana State Education School Cadre (Group-C) Service Rules, 2012 and amended from time to time.
  10. No TA/DA will be admissible to the candidate for joining as TGT.
  11. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
  12. If he/she gets an appointment as TGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/ facts which are detected later on, he/she would be liable for termination of service without any notice.
  13. This appointment letter is purely provisional subject to providing a duly signed undertaking, verification of character and antecedents of the candidate concerned, document verification as well as any other documents deemed necessary for appointment, however, it should be got verified within stipulated period as per CS Haryana instructions no. 52/06/2018-2HRIII dated 05.02.2024. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is found in verification process as stated above or is reported against him/her at later stage as mentioned in Government Instruction



No. 52/08/2002-3GS-III dated 23.06.2022 and instruction No. 52/06/2018-2HR-III dated 05.02.2024. In case, any of the information is found incorrect or in case, the verification confirms that facts given by the candidate were not correct, then the appointment of concerned candidate(s) shall stand terminated forthwith without any further notice.


14. In case of any contradiction between terms & conditions of this appointment letter & statutory rules then in such a case statutory Rules of state Govt. (Govt. of Haryana) as well as of the department shall prevail.
15. Medical Fitness Certificate should be submitted before joining in the office of concerned DEEO when the regular appointment letter is issued.
