Order No. 2/78-2022 D&L (1)

Dated Panchkula the,

Whereas, an FIR No. 507 dated 16.08.2016 was lodged at Police Station Sadar, Bhiwani against Sh. Sanjay Kumar (091830), TGT Math, GHS Dhani Peeranwall, Distt. Hisar now presently posted at GMS Pipalghati [6615] District Panchkula. Consequently, the delinquent was placed under suspension vide order dated 20.04.2017 and reinstated keeping enquiry pending vide order dated 05.04.2018 after getting bail from Hon'ble High Court.

After completion of trial, the delinquent was convicted and sentenced U/s 307 of IPC by Addl. Sessions Judge (Exclusive Court), Bhiwani vide judgment dated 11.09.2017/13.09.2017 for the period of 03 years and with fine of Rs. 2000/-. Resultantly, he was dismissed from service vide this office order No. 2/78-2022 D&L(1) dated 31.10.2022/01.12.2022.

Being aggrieved with the judgment of trial court, the delinquent had already preferred an appeal before the Hon'ble High Court vide No. CRA-S-3555-SB-2017 against the Judgment dated 11.09.2017/ 13.09.2017 passed by Additional Sessions Judge (Exclusive Court), Bhiwani against the conviction and sentence for commission of offence punishable under Section 307 IPC.

Subsequently, the Hon'ble High Court of Punjab and Haryana decided the said appeal vide its judgment dated 28.05.2024. The operative part of the order of judgement is as under :-

**"Considering the facts of the present case, as well as the principle of law laid down by Hon'ble Supreme Court, it would be futile to drag the present proceedings, as continuation of the criminal proceedings, despite settlement and compromise inter se parties, would amount to abuse of process of law. Accordingly, in exercise of power under Section 482 of the Cr. P.C., this Court allows the instant petition. The FIR No. 507 dated 16.08.2016, under Sections 307/506 of the IPC, registered at Police Station Sadar, Bhiwani along with all consequent proceedings arising therefrom, is hereby quashed on the basis of a compromise and judgment of conviction dated 11.09.2017, and order of sentence dated 13.09.2017 is hereby set aside, subject to cost of Rs. 5,000/- being forthwith deposited by the petitioner with the District Legal Services Authority concerned."**

Now the delinquent Sh. Sanjay Kumar has submitted representation and requested to review the dismissal order issued vide order No. 2/78-2022 D&L(1) dated 31.10.2022/ 01.12.2022 in view of the Hon'ble High Court judgement dated 28.05.2024.


Thereafter, he was granted an opportunity of personal hearing on 29.10.2024. The delinquent appeared for personal hearing and explained in detail verbally as well by submitting a representation in writing explaining the facts & the circumstances of the

case. The delinquent also explained that he was dismissed from the service on the ground of conviction awarded to him by Additional Session Judge (Exclusive Court), Bhiwani vide its order dated 13.09.2017. The delinquent stated that now the said FIR No. 507 has been quashed and the sentence awarded has also been set aside by the Hon'ble High Court vide its judgment dated 28.05.2024 and requested for reinstatement in service by reviewing the earlier office order of dismissal. However, the delinquent has also stated that another FIR No. 0269 pending in trial Court, Hisar. He has attached the statement of PWs as evidence to prove that he is innocent in the matter and has been dragged intentionally.

Accordingly, the matter was considered and after going through the facts of the case on record, it is decided to reinstate him in service and posted at GMS Pipalghati [6615], Block Pinjore, District Panchkula, in view of the Hon'ble High Court judgment dated 28.05.2024 and also subject to the outcome of decision by Hon'ble Court Hisar in FIR No. 0269 which is under trial.
