Whereas, the names of the candidates were recommended for the post of TGT Science vide No HSSC/Confid./Recomm./2024/442 dated 27.07.2024 against Advt. No. 2/2023, Category No. 7 and 12 by Haryana Staff Selection Commission, Panchkula. While, recommending the name of the selected candidates, the HSSC, Panchkula had made an observation as under:-

"The selected candidates have not been medically examined and no special enquiry into their antecedents has been made. The documents pertaining to their Education Qualification, age, Caste/Category and Universities as claimed by them in the application form may please be got checked/verified from the issuing authorities, before they are allowed to join their duties. A copy of the appointments letter issued to the candidates may also be endorsed to the Commission."

Thereafter, a list of 28 candidates was received in the Department from Haryana Staff Selection Commission vide memo no. HSSC/01/28/2021/2S/4257 dated 17.09.2024 to clarify, whether as per advertisement no. 02/2023 and service rule of the department these 28 candidates fulfill the essential educational qualification for the post of TGT Science against Advt. No. 02/2023 or not.

Accordingly, a joint committee of subject expert from Kurukshetra University Kurukshetra and Maharshi Dayanand University, Rohtak, checked the documents of above mentioned candidates on dated 04.11.2024 and submitted a report regarding eligibility of these candidates. As per report, the below mentioned candidates are not eligible for the post of TGT Science against advt. No. 02/2023.
