

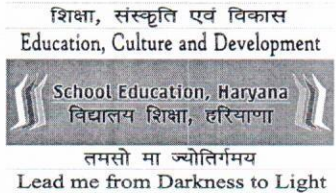

Also if, any senior employees is found entitled for promotion he/she will be eventually promoted by the department by virtue of his entitlement for promotion.
