On the recommendation of Haryana Staff Selection Commission, Panchkula conveyed vide their memo No. HSSC/Confd./Recomm/2024/442 dated 27.07.2024 and memo No. HSSC/Confd./Recomm/2024/495 dated 14.08.2024 against advertisement no. 02/2023 Cat. Terms and conditions: -

1. The candidates are appointed purely on provisional/temporary basis. This appointment is against temporary post and their confirmation against substantive post shall be considered on the basis of their seniority, record of service and as and when such post is available.
2. The candidates shall have to take an oath of allegiance to the Constitution of India before issuance of regular appointment letter.
3. The candidates shall not claim seniority on the basis of this order. Their inter-se seniority will be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time.
4. The appointment will be subject to the final outcome of the pending court case(s), if any.
5. The candidates shall remain on probation for a period of two years, extendable upto three years as per rules 27 of HCS (General) Rules, 2016.
6. In the matters, not specifically mentioned in this communication, the candidates shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
7. In case of reserved category candidates, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then their service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. The candidates shall be governed by the Haryana State Education School Cadre (Group-C) Service Rules, 2012 (amended from time to time).
9. No TA/DA will be admissible to the candidate for joining as TGT.

10. If at any time during the course of their temporary appointment, they desires to resign, then in such eventuality, they shall be required to give one month's notice or forfeit, in lieu thereof, their one month's salary including allowances etc.
11. If they gets an appointment as TGT on the basis of thier furnishing ineligible/invalid qualifications, false/forged or fraudulent information/ facts which are detected later on, they would be liable for termination of service without any notice.
12. This appointment letter is purely provisional subject to providing a duly signed undertaking, verification of character and antecedents of the candidate concerned as well as any other documents deemed necessary for appointment, however, it should be got verified within stipulated period as per CS Haryana instructions no. 52/06/2018- 2HRIII dated 05.02.2024. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is found in verification process as stated above or is reported against him/her at later stage as mentioned in Government Instruction No. 52/08/2002-3GS-III dated 23.06.2022 and instruction No. 52/06/2018-2HR-III dated 05.02.2024. In case, any of the information is found incorrect or in case, the verification confirms that facts given by the candidate were not correct, then the appointment of concerned candidate(s) shall stand terminated forthwith without any further notice.
13. In case of any contradiction between terms & conditions of this appointment letter & statutory rules then in such a case statutory Rules of State Govt. (Govt. of Haryana) as well as of the department shall prevail.
14. Medical Fitness Certificate should be submitted before the joining.
15. The candidate is directed to join duty at place of posting at the earliest (preferably within 7 days). Joining/Non-Joining report should be sent at tgtbranch@gmail.com
