TERMS AND CONDITIONS OF SANCTION:-

1. The amount of Compassionate Financial Assistance so granted shall be equal to the pay and other allowances that were last drawn to **Late Sh. Pardeep Kumar, JBT, Govt. Primary School, Sainipura (Sonipat)**.
2. That the dependent of the deceased Govt. Employee will to receive the family pension, if eligible under the applicable Rules & instructions only after the expiry of the period for which the compassionate monthly financial assistance is granted.
3. That house rent allowance for a period of two years at the rate drawn immediately before death or admissible at the station from where the Compassionate Financial Assistance is being drawn, whichever is less, or to retain Government

accommodation, if already occupied, for a period of two years on payment of normal licence fee as per the policy dated 02.08.2019.

4. That the house rent allowance shall not be a part of allowances for the purpose of calculation of monthly financial assistance for the dependent of the deceased govt. employee who was expired before 01.08.2019.
5. That the claimant shall open an account with any of the nationalized banks and the payment of monthly financial assistance will be made through bank draft or cheque or bank transfer or electronic transfer every month by the concerned Drawing and Disbursing Officer.
6. That the lawful recovery outstanding against the deceased govt. employee be made as per Rules & instructions issued from time to time after obtaining an undertaking from eligible family member by the DDO before start of payment of MFA/CFA.
7. The eligible family member in receipt of compassionate monthly financial assistance shall have to appear personally or furnish life certificate and income certificate duly attested by a gazetted officer or village Sarpanch or Municipal Councillor of the area of his residence to the concerned Head of office once in every six months.

Note : In the sanction of CFA, a condition will be imposed that DEEO Sonipat and the DDO, Govt. Middle School, Kot (Sonipat) will ensure that the adjustment of the amount of family pension already drawn and paid for the period from 02.05.2021 to 30.04.2023 to the wife of the deceased employee from the CFA payable to him for the period 02.05.2021 to 28.02.2027 will be made.
