The above promotions subject to the following terms and conditions:-

1. That this promotion is subject to condition of refixation of seniority/fixing the roster point. Also if, any senior employees is found entitled for promotion he/she will be eventually promoted by the department by virtue of his entitlement for promotion.
2. That this promotion is subject to condition that all the particulars and data supplied by concerned employee and field office is correct. In the event of any information subsequently found to be factually or erroneous or mis-represented, the promotion so granted shall be withdrawn immediately without giving any notice or assigning any reason. Hence, such promotion order is subject to review/cancellation in case of any discrepancy regarding eligibility is found at any stage.

4. In case, it transpires at any stage that the teacher is ineligible for this promotion, the teacher will be reverted to his/her original post without giving any notice.
