

Whereas, the present CWP No. 32249 of 2024 Bijender Singh and others Vs. State of Haryana & others the petitioners prayed interalia for issuance of writ in the nature of mandamus directing the respondents to grant the benefits of additional 10% of the basic pay with Dearness allowances alongwith consequential benefits and interest thereon with future benefits, on account of the fact that petitioner had been posted in District Nuh (Mewat).

The said writ petition came up for hearing before the Hon'ble High Court on 29.11.2024 and the following direction was issued:-

"The petition has been filed seeking a writ of mandamus directing the respondents to grant the benefit of additional ten per cent of the basic pay with dearness allowance, along with all consequential benefits, on account of the fact that petitioners had been posted in district Nuh (Mewat).

2. Learned counsel for the petitioners submits that at this stage, the petitioners will be satisfied in case they are permitted to make fresh representation(s) before the concerned respondents no.2 and 3, as the case may be, raising the grievances as has been raised in this petition, and the same may be ordered to be decided within a specified period

3. Notice of motion.

4. Ms. Tanushree Gupta, Deputy Advocate General, Haryana, accepts notice and submits that in case any such representation(s) are filed by the petitioners within two weeks from today, the same will be decided by the concerned respondents no.2 and 3-Director General, Department of Secondary/Elementary Education, as the case may be, by passing speaking order in accordance with law within three months of receiving the representation(s).

5. In view of the statement made, learned counsel for the petitioners has no objection to the petition being disposed of in terms thereof.

6. Ordered accordingly.

7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹50,000 to the petitioners.

It is stated here that the claimant No. 1 to 5 and 7 relates to the O/o Directorate of Secondary Education and only claimant No. 6 relates to O/o Directorate of Elementary Education.

In compliance of this order dated 29.11.2024, the Legal Notice dated 03.12.2024 of the Claimant No. 6 i.e. Sh. Satyender Pal was examined at length and it is evident that the Claimant was appointed direct as TGT/Master (Science) on 18.06.2001. The claimant had participated in General Transfer Drive, 2017 held on 06.09.2017 in which the claimant filled-up more than 80 preference/choices out of which the claimant was allotted preference no. 2 i.e GSSSS Gudha (3159) Distt. Jhajjar (Zone-1). Thereafter the claimant was promoted as Elementary School Head Master vide order No. 15/32-2019 HRM-III(1) dated 24.08.2019 with condition to participate in up coming Transfer Drive for promotional post/station and the claimant participated in General Transfer Drive, 2019 held on 06.09.2019 in which the claimant had not opted for anywhere category instead had filled up more than 124 preference/choices. From the

choices/preferences opted by the claimant none of the preferences were allotted to the claimant, therefore the station was allotted in anywhere category i.e. GSSS Doha (892), District Nuh (Zone-6). It is stated here that initially the claimant could have opted for anywhere category when options were being sought but the claimant did not opt/make a choice of "Anywhere in State" therefore he is not covered under the Teacher Transfer Policy, 2016 (amended time to time). Further, it is stated that the claimant had participated in General Transfer Drive, 2022 and the claimant is currently working at Shaheed Sipahi Surat Singh Government Senior Secondary School Chhuchhakwas, Jhajjar, (3230), Zone 4.

In this regard, it is stated here that the claim of Claimant is not maintainable as per as per Teacher Transfer Policy, 2016 (amended in 2017). The para no 11 of Teacher Transfer Policy, 2016 dated 01.06.2017 is as under:-

"11. Incentive for serving on the choice of "Anywhere in State" if a teacher opts for 'any where in the State' and is thereafter posted in a school in Morni Hills Area or Mewat District against a vacancy for which no teacher has opted, he/she will be paid additional 10% of the Basic pay+D.A. during the said posting."

In this regard, it is stated here that the claim of Claimant is not maintainable as per as per Teacher Transfer Policy, 2016 (amended time to time). The para no 11 of Teacher Transfer Policy, 2016 dated 13.04.2022 is as under:-

"11. If a teacher is willing to be posted in a school located in Morni Education Block of Panchkula District or Hathin Educational Block of Palwal District or Nuh District against a vacancy and who have neither declared Panchkula, Palwal or Nuh respectively as their home District nor have completed class 10th or 12th from school located in Morni Educational Block of Panchkula District or Hathin Educational Block of Palwal District or Nuh District respectively, he/she will be paid additional 10% of the Basic pay+D.A. during the said posting."

Further, the claimants are praying to grant the benefits as per the clause 11 of the Teacher Transfer Policy, 2016 (amended from time to time) issued by the Directorate Elementary Education, Haryana, Panchkula respectively. In this regard, it is stated here that the benefit of additional 10% of the Basic pay+D.A. is to be given as per para 11 of Teacher Transfer Policy, 2016 (amended in 2017) dated 01.06.2017 to those teachers who opts for 'any where in the State' and is thereafter posted in a school in Morni Hills Area or Mewat District against a vacancy for which no teacher has opted, he/she will be paid additional 10% of the Basic pay+D.A. during the said posting and further it is stated that the benefit of additional 10% of the basic pay +D.A. is to be given as per para 11 of Teacher Transfer Policy amended dated 13.04.2022 to If a teacher is willing to be posted in a school located in Morni Education Block of Panchkula District or Hathin Educational Block of Palwal District or Nuh District against a vacancy and who have neither declared Panchkula, Palwal or Nuh respectively as their home District nor have completed class 10th or 12th from school located in Morni Educational Block of Panchkula District or Hathin Educational Block of Palwal District or Nuh District respectively, he/she will be paid additional 10% of the Basic pay+D.A. during the said posting. Hence, the demand/claim made by the claimant in lieu of participation in General Transfer Drive 2017, 2019 & 2022 is not tenable in view of Teacher Transfer Policy, 2016 (amended time to time).

In view of above, the claimant is not entitled for additional 10% of the Basic pay+D.A. as in General Transfer Drive, 2019 as the choices/preferences opted/filled by the claimant none of preferences were allotted to the claimant, therefore the station was allotted in anywhere category i.e. GSSS Doha (892), District Nuh (Zone-6). Hence, the claim of claimant is not tenable.

In view of the above narrated facts, I, undersigned, is of the considered view that the claim of the Claimant is not maintainable and hereby rejected accordingly.

I order accordingly.

# Order No. 17/142-2024 ESHM (2) Dated, Panchkula, the 19/2/25

Whereas Petitioner(s) has filed CWP No. of 17443 of 2024 titled as Om Vati and others Vs. State of Haryana and others praying therein for issuance of a writ in the nature of mandamus directing the respondents grant one annual increments to the petitioners on 1<sup>st</sup> of January and 1<sup>st</sup> of July of every year, after Rule 10 of The HCS (RP) Rules 2008 dated 30.12.2008 (Annexure P-1) held contrary by the Hon'ble High Court in CWP No. 14857 of 2023 Jagdish Raj Gupta versus State of Haryana and others dated 15.04.2024 (Annexure P-6) to the extent provides for Uniform Date of increment i.e. 1<sup>st</sup> of July of every year one annual increment despite that the petitioners have not been granted annual increment in the preceding year of their retirement. It is further prayer that the pension of petitioners by granting them annual increment in their last retiring year before their retirement they have completed requisite 6 months to 12 months of service for grant of annual increment with all consequential benefits of arrears of pay and pension etc. along with interest 12% PA.

Whereas, the Hon'ble High Court vide order dated 05.08.2024 disposed of this writ petition with following directions:-

"In view thereof, without going into the merits of the case, the petition is disposed of with a direction to respondents No.2 and 3-Director, Secondary Education/Elementary Education, as the case may be, to consider and decide the pending legal notices, dated 10.06.2024, in the light of the judgments mentioned above by passing a speaking order thereupon, within a period of three months of receiving a certified copy of this order."

In compliance of the order dated 05.08.2024, the Legal Notice dated 10.06.2024 (Annexure P-4 & P-5) has been considered and found that the Petitioners No. 19, 36, 37 & 44 in the writ petition are ESHMs and related to Elementary Education Department.

In Civil Appeal No. 2471 of 2023 titled as the Director (Admn. and HR) KPTCI. And others vs. C.P. Mundinamani and others, the Hon'ble Supreme Court mainly relied upon Regulation 40(1) of Karnataka Electricity Board Employees Service Regulations. The Hon'ble Supreme Court observed that Regulation 40(1) states that 'an increment accrues from the day following that

on which it is earned. Thus, the appellants have earned the increment on the date of their retirement i.e. when they were in service and what remains thereafter, is only its enforcement in the form of payment which accrues the very next day and they need not be in service on that date to earn the increment. In rest of the orders the Hon'ble Supreme Court has mentioned different court orders.

However, the general principles of granting annual increment are explained as under:-

- a. An increment is a part of the pay not that of Pension. A Government servant is allowed increment while discharging duties of his post. Thus, although an increment may accrue to a Government servant on a particular day but he must be in service and discharging the duties attached to that post on that day.
- b. Annual increase in pay is granted to an employee with the stipulation that he will perform better in future due to his past experience.
- c. A Government servant ceases to draw pay and allowances attached to his post with effect from the date on which he ceases to discharge the duties of that post i.e. on the date of retirement.
- d. On the next day after retirement, the Government employee doesn't remain in service rather, he became a pensioner.
- e. Hence, no increase in pay can be granted after retirement for the purpose of conhancement in pension.
- f. This position can be understood from an example. Suppose an employee is appointed for 5 years in the pay scale of Rs. 10000- 325-13900. He joins service on 1st July 2008. His pay is regulated as under:-

It is clear from the above table that his last pay of Rs. 11300/- in valid upto 30.06.2013 and he retired on the same date ie. 30.6.2013. If another increment is granted on 01.07.2013, that will be valid for next year ie. 01.07.2013to 30.06.2014. However, he is not in service for this period even for a single day. Therefore, he cannot be considered for grant of increment as on 01.07.2013 unless he is in service as on 01.07.2013.That no such benefit is available in other pension schemes like CPF/EPF/NPS etc.

- g. That the amended rule 6.24 (2) provides that pension must not be increased on account of increase in pay not actually drawn.
- h. That Rule 36 of HCS(Pay) Rules, 2016 prescribes as under:-

"Increment on 1st January or 1st July while on duty-

When a Government employee is not actually present in office on the date of his next increment (i.e. on 1st January or 1st July) but under the rules he is on duty, like on training, tour, compulsory waiting period, availing joining time, vacation or otherwise, the normal increment shall be granted if the same shall have otherwise been admissible had he been in office on that day."

In view of provision of this statutory rule, the prayer of the petitioner is not tenable.

i. That Rule 143 of HCS (General) Rules, 2016 prescribes as under:-

"Except as otherwise provided in these rules, every Government employee shall retire from service on afternoon of the last day of the month in which he attains the age of retirement prescribed for him or for the post held by him in substantive or officiating capacity, as the case may be. However, a Government employee whose date of birth is the first of a month shall retire from service on the afternoon of the last day of the preceding month on attaining the prescribed age....."

In view of this Rule, such employees, who are born on 1st day of next month, are also not entitled for such increment.

Whereas, the Hon'ble Kerala High Court has decided O.P.(CAT), No. 61 of 2020 vide order dated 22.11.2022. The operative part of these orders is as under:

### "xxxxxxxxx

7.We are therefore of the view that the issue of whether a Government servant who retired on the last working day of the preceding month and whose annual increment falls due on the first of the succeeding month is entitled for sanction of annual increment for the purpose of pension and gratuity must be answered <u>in favour of the petitioners herein</u> and against the respondents. We do so by setting aside the impugned orders of the Tribunal and allowing these O.P.(CAT)'s. Xxxxxxxx."

While delivering the above orders, the Hon'ble Kerala High Court has considered the Rules governing the issue, namely, the Fundamental Rules [F.R. 17, F.R. 24, F.R. 56(a) and the 1 proviso to F.R. 56(a)) and Rules 3, 5, 14, 33 and 34 of the CCS (Pension) Rules. Further, the Hon'ble Kerala High Court has also considered the different decisions of various courts either in favour of retired employees or in favour of the Government.

Whereas, such petitioners/employees who have completed six months or more but less than one year service before their retirement has also filed various writ petitions claiming therein one increment. But the same is not permissible on the following grounds:-

- a. That the concept of uniform date of annual increment i.e. 1st July of every year was introduced during implementation of 6th CPC framing HCS(RP) Rules, 2008 vide notification dated 30.12.2008.
- b. The Rule 10 of HCS (RP) Rules, 2016 provides that an employee shall be entitled to only one annual increment either on 1st January or 1 July depending on the date of his appointment, promotion or grant of financial upgradation. It is clear that increment is to be granted only after completion of one year, however, qualifying service during previous year can be of six months or more.
- c. While introducing uniform date of annual increment, the employees whose increment was due after 1st July, 2006 upto 31st December,

2006, their increment was preponed to 1st July 2006. Thus they were given extra benefit in order to adhere a uniform date of increment and granted annual increment even before the completion of statutory 2 calendar months. Thus they were extra benefited.

- d. Similarly, those employees whose annual increment was due between 1 February, 2006 to 30th June 2006 were also given one annual increment on 1.1.2006 vide order dated 16.4.2012. Thus they were also extra benefited.
- e. Vide general order of F.D. dated 7.1.2015, such persons who joined service after 1.1.2006 were allowed proportionate increment upto 1 July of the joining year so that thereafter a uniform date of annual increment ie. 1st July can be maintained.
- f. If this extra benefit which was given to the employee viće government notification dated 30.12.2008 and vide order dated 16.04.2012 & 07.01.2015 due to introducing a uniform date of annual increment was not given to them, their increment will not fall due on 1st July after retirement on 30th June.

That neither Rule 10 of HCS (RP) Rules, 2008 nor Rule 20 of HCS (ACP) Rules, 2008 provides the benefit of proportionate increment. The benefit of proportionate increment vide letter dated 07.01.2015 was made admissible in relaxation of stipulation under Rule 10 of HCS (RP) Rules, 2008 and Rule 20 of HCS(ACP) Rules, 2008 with respect to those employees only who joined service as fresh entrant between 1 January & 1st July as one-time measure. Therefore, the benefit of proportionate increment to such retired Government Employees/ representationist is not admissible.

Thus, it cannot be held that the Rule also provides that if a person has rendered more than six months service, he would be deemed to have completed 12 months of service for the purpose of grant of increment.

Apart from the above, in a similar issue the State Government has filed SLP against the order dated 15.04.2024 passed in CWP No. 14857 of 2023 titled as Jagdish Rai Gupta & others Vs. State of Haryana & others. Accordingly, the Hon'ble Supreme Court in SLP (C) (Diary No. 37861/2024 titled as State of Haryana & others Vs. Jagdish Rai Gupta) vide its interim order dated 02.09.2024 has not only issued notice in the applications seeking

condonation of delay as well as in the main case but has also directed that  $h_{i}$  the meanwhile, the High Court shall not proceed with the contempt proceedings, if any.

Accordingly, in the light of above mentioned rules, factual position and order dated 02.09.2024 passed by the Hon'ble Apex Court in Jagdish Rai Gupta's case (Supra), the Legal Notice dated 10.06.2024 (Annexure P-4 & P-5) of is found to be devoid of any merits and, therefore, cannot be accepted at this stage.

I, therefore, pass the order accordingly.

# Order No. 17/131-2024 ESHM(2) Dated, Panchkula, the \8/2/25

Whereas Petitioner(s) has filed CWP No. of 31698 of 2024 titled as Bhagat Singh and others Vs. State of Haryana and others praying for issuance of a writ in the nature of mandamus directing the respondents to grant the benefit of one increment which becomes due on 1<sup>st</sup> July of the retirement of the years of the petitioners, with all consequences benefits and further direction be issued to the respondent to revise the pay and accordingly pension and draw all pensionary benefits arrears alongwith 18% interest to the petitioners in view of the Judgment 'The Director (Administration and HR) KPTCL and others Vs. C.P. Mundinamani and others', (2023 SCC Online SC40 Annexure P-2).

Whereas, the Hon'ble High Court vide order dated 25.11.2024 disposed of this writ petition with following directions:-

"This petition has been filed seeking a writ of mandamus directing the respondents to re-fix the petitioners' pension by granting them benefit of annual increment in the last year of retirement.

- 2. Learned counsel for the petitioners contends that the petitioners had completed one year satisfactory service prior to their retirement, and became entitled to one annual increment on that basis. The law in this regard stands settled by the Supreme Court in The Director (Admn. and HR) KPTCL and others v. C.P.Mundinamani and others, 2023 SCC Online SC 401. Still, the petitioners' claim has not been considered, nor has their legal notice, dated 20.07.2024, Annexure P-1, been decided so far.
- 3. Notice of motion.
- 4. Mr. R.S. Budhwar, Addl. A. G., Haryana, accepts notice and submits that the pending legal notice, dated 20.07.2024, will be decided by respondent no.3/Additional Chief Secretary, Education Department, by passing a speaking order thereupon within three months, keeping in view the law laid down in C.P.Mundinamani case (supra), as well as the directions SLP (C) No.4722 of 2021, that, 'The judgment dated 11.04.2023 will be given effect to in case of third parties from the date of the judgment, that is, the pension by taking into account one increment will be payable on and after 01.05.2023. Enhanced pension for The period prior to 30.04.2023 will not be paid'.

5. In view of the statement made, learned counsel for the

petitioners has no objection to the petition being disposed of in terms thereof.

- 6. Ordered accordingly.
- 7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹50,000 to the petitioners."

In compliance of the order dated 25.11.2024, the Legal Notice dated 20.07.2024 (Annexure P-1) has been considered and found that the Petitioner No. 1 in the writ petition is ESHM and related to Elementary Education Department,

That in Civil Appeal No. 2471 of 2023titled as the Director (Admn. and HR) KPTCI. And others vs. C.P. Mundinamani and others, the Hon'ble Supreme Court mainly relied upon Regulation 40(1) of Karnataka Electricity Board Employees Service Regulations. The Hon'ble Supreme Court observed that Regulation 40(1) states that 'an increment accrues from the day following that on which it is earned. Thus, the appellants have earned the increment on the date of their retirement i.e. when they were in service and what remains thereafter, is only its enforcement in the form of payment which accrues the very next day and they need not be in service on thatdate to earn the increment. In rest of the orders the Hon'ble Supreme Court has mentioned different court orders.

However, the general principles of granting annual increment are explained as under:-

- a. An increment is a part of the pay not that of Pension. A Government servant is allowed increment while discharging duties of his post. Thus, although an increment may accrue to a Government servant on a particular day but he must be in service and discharging the duties attached to that post on that day.
- b. Annual increase in pay is granted to an employee with the stipulation that he will perform better in future due to his past experience.
- c. A Government servant ceases to draw pay and allowances attached to his post with effect from the date on which he ceases to discharge the duties of that post i.e. on the date of retirement.
- d. On the next day after retirement, the Government employee doesn't remain in service rather, he became a pensioner.

- e. Hence, no increase in pay can be granted after retirement for the purpose of enhancement in pension.
- f. This position can be understood from an example. Suppose an employee is appointed for 5 years in the pay scale of Rs. 10000- 325-13900. He joins service on 1st July 2008. His pay is regulated as under:-

It is clear from the above table that his last pay of Rs. 11300/- in valid upto 30.06.2013 and he retired on the same date ie. 30.6.2013. If another increment is granted on 01.07.2013, that will be valid for next year ic. 01.07.2013to 30.06.2014. However, he is not in service for this period even for a single day. Therefore, he cannot be considered for grant of increment as on 01.07.2013 unless he is in service as on 01.07.2013.That no such benefit is available in other pension schemes like CPF/EPF/NPS etc.

- g. That the amended rule 6.24 (2) provides that pension must not be increased on account of increase in pay not actually drawn.
- h. That Rule 36 of HCS(Pay) Rules, 2016 prescribes as under:-

"Increment on 1st January or 1st July while on duty-

When a Government employee is not actually present in office on the date of his next increment (i.e. on 1st January or 1st July) but under the rules he is on duty, like on training, tour, compulsory waiting period, availing joining time, vacation or otherwise, the normal increment shall be granted if the



same shall have otherwise been admissible had he been in office on that day."

In view of provision of this statutory rule, the prayer of the petitioner is not tenable.

i. That Rule 143 of HCS (General) Rules, 2016 prescribes as under:-

"Except as otherwise provided in these rules, every Government employee shall retire from service on afternoon of the last day of the month in which he attains the age of retirement prescribed for him or for the post held by him in substantive or officiating capacity, as the case may be. However, a Government employee whose date of birth is the first of a month shall retire from service on the afternoon of the last day of the preceding month on attaining the prescribed age....."

In view of this Rule, such employees, who are born on 1st day of next month, are also not entitled for such increment.

Whereas, the Hon'ble Kerala High Court has decided O.P.(CAT), No. 61 of 2020 vide order dated 22.11.2022. The operative part of these orders is as under:




