This is to bring to your attention that the Seat Declaration Portal is currently active and schools are submitting seat-related data as part of the admission process under RTE provisions.

Upon scrutiny of the data submitted by various schools, it has been observed that some schools have made incorrect declarations with regard to the number of seats at

the entry-level classes. A few examples are illustrated below:

If the entry-level class starts from UKG, then only UKG class seats should be declared.

If the entry-level class starts from Class 1st, then only Class 1st seats should be declared. Declaring seats in multiple classes (e.g., Nursery, LKG, UKG, and 1st

simultaneously) is not permitted and will be treated as incorrect.

Furthermore, it is important to reiterate that schools are required to submit the total number of seats available for entry-level classes. The system will automatically calculate 25% of these seats based on the data provided by the

All private schools are requested to verify and ensure that their data on the portal is submitted strictly in accordance with this clarification. In case of any discrepancy or wrong declaration, schools are advised to rectify their data upto closing date i.e. 14.04.2025 (11.59.59 P.M.).

Note:-

Several schools have only partially submitted their seat declaration data, and have not yet submitted their data as 'final'. Please note that only applications marked as 'Final Submitted' will be considered. Applications that have not been submitted as final will not be considered.
