In continuation of office order No. 2/14-2021 TGT R&A (1) dated 21.03.2025, wherein the names of the candidates as per list attached were recommended for the post of various subjects of TGTs (Rest of Haryana) vide No. HSSC/Confid./Recomm/2024/442 dated 27.07.2024 against Advt. No. 02/2023, under various Categories by Haryana Staff Selection Commission, Panchkula. The candidature of the absentees candidates were cancelled after following due procedure.

Whereas, the candidate at Sr. No. 10 i.e. Sh. Sanjay Kumar Roll No.2231103444 Merit No. 465 in the TGT Science list appeared for DVC and he has been found ineligible as per the report of DVC. The name of the candidate was inadvertently mentioned in the list of absentee candidates. However, the candidature of the candidate has been rejected on the basis of not fulfilling the requisite eligibility criteria for the said post.






