उपरोक्त विषय पर निदेशालय के पत्र कमांक KW 16/2-2023 जी०एस० (3) दिनांक 28.03.2025 की निरन्तरता में।

संदर्भित पत्र अनुसार निःशुल्क व अनिवार्य बाल शिक्षा का अधिकार अधिनियम 2009 के सैक्शन 12 (1) (C) के प्रावधान अनुसार कक्षा प्रथम या इससे पूर्व की कक्षाओं में दाखिले हेतु कुल सीटें घोषित करने बारे राज्य के सभी मान्यता प्राप्त प्राईवेट विद्यालयों को निर्देश जारी किये गए थे। दिनांक 14.05.2025 को MIS पर दर्ज 10744 विद्यालयों को एक अन्य अवसर प्रदान करते हुए दिनांक 16.05.2025 से 23.05.2025 तक Seat Declaration पोर्टल को पुनः खोला जा रहा है, तािक विद्यालयों द्वारा निर्धारित समयाविध में पोर्टल पर कक्षा प्रथम या इससे पूर्व की कक्षाओं (प्रवेश स्तर) में कुल सीटें पुनःदर्शायी जा सकें।



NOTICE

Memo No: 8/28-2025-PS (1)

All Recognized Private Schools are hereby informed that the Seat Declaration Portal was made operational to facilitate compliance with the provisions of the **Right of Children to Free and Compulsory Education Act, 2009 (RTE Act, 2009)**. As per instructions, schools were required to declare the total number of seats at the entry-level class by **14.04.2025**.

It has been observed that some schools either failed to submit the required information or declared incorrect data (e.g., declaring fewer than four seats). Consequently, their **School MIS accounts were temporarily blocked** and **Show Cause Notices** were issued.

Most of the defaulting schools have now submitted their replies. After due consideration, the Department has decided to grant a **final opportunity** to all private schools to submit or rectify their entry-level seat declarations in accordance with RTE norms.

All concerned schools are directed to:

- Schools must access the Seat Declaration Portal and update the required details accurately. It is further clarified that schools are required to submit the total number of seats in the entry-level class, based on which the system will automatically calculate 25% seats as per RTE provisions.
- This is the final chance to comply. The **last date for submission is** 23.05.2025.
- No further extension shall be granted under any circumstances.

Non-compliance within the stipulated period will invite **strict disciplinary action**; each school is **responsible for uploading a valid and genuine recognition certificate** on the Seat Declaration Portal. Submission of incorrect, expired, or forged certificates may attract **adverse action**, including the suspension of MIS access and proceedings for **withdrawal of school recognition** under applicable rules.

Last Time a significant number of schools under the Seat Declaration Portal have not submitted their application in final form on the portal. **Please note that only final submitted applications will be considered.** Department understand that some schools may have edited/unlocked their applications to update details but may have **missed the final submission step** afterward.

Kindly be aware that **editing or unlocking the form does not automatically submit it as final** — you must explicitly click on "Final Submit" after making any changes.

It is further clarified that, following the submission of seat data, the Department will initiate a verification drive of the declared seats as well as the uploaded recognition certificates.

Note: The school must carefully check the information before submitting the same on the portal. The school will be responsible for any mistake committed in the online application form and Department shall not be responsible or liable in any way. Any information submitted by an school in the online application will bind the school personally and if found to be false, then school shall be liable for cancellation **recognition** under applicable rules.
