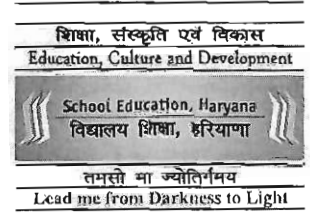

2. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
3. The promotes will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.
4. The promotee(s) granted promotion from deemed date shall be not entitled for arrears of pay and they will be granted benefit of notional pay fixation & Seniority.
5.
