In accordance with the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (RTE Act), the Government is committed to ensuring equitable access to quality education for all children, particularly those from economically weaker sections (EWS) and disadvantaged groups. As part of this commitment, a structured process is being implemented for the admission of eligible children into private unaided schools under Section 12(1)(c) of the RTE Act, which mandates the reservation of a specified percentage of seats for such children.

This public notice outlines the tentative schedule for the verification of school seat availability, parent application process, result declaration, and final admissions for the academic year 2025-26. The timeline provided below is subject to adjustments based on administrative requirements, but stakeholders are advised to adhere to the specified dates and remain updated via the official departmental website i.e. <https://harprathmik.gov.in>:

| 3 | Verified School List | 09.06.2025 to 12.06.2025 | Verification of seats at the branch level. |

Previously, the age criteria were not approved. Minor updates to the portal may be incorporated, including distance-based (0 to 1 KM and 1 to 3 KM) with school choice and other features, as required. |
