In continuation of order No. 8/50-2021 TGT Pro(1) dated 08.07.2022 and in pursuance of instructions O/o Chief Secretary, Haryana issued vide letter No. 22/10/2013-1GS-III dated 17/19.04.2017 & 22/59/2020-1GS-III dated 25.03.2022 amended from time to time, the following teacher is hereby provisionally promoted with benefit of notional pay fixation/ seniority not monetary benefit (arrears) against the post of TGT Social Science, in the pay scale notified under Haryana Civil Services (Pay) Rules applicable at that particular time under 3% reservation in PwD quota upon considering her representation dated 20.09.2024. The details of employee are as under:-

**Note:-** The said employee is hereby posted temporarily in the same school in which she was already working subject to the condition that they will compulsory participate in the upcoming transfer drive.

The above notional promotions are however subject to the following conditions:-

1. That this promotion is subject to condition of refixation of seniority/fixing the roster point. If any official is found senior to him/her at any stage due to refixation of his/her seniority/roster wise point, he/she shall be reverted without giving any notice. Also if, any senior employees is found entitled for promotion he/she will be eventually promoted by the department by virtue of his/her entitlement for promotion.
2. That this promotion is subject to condition that all the particulars and data supplied by concerned employee and field office regarding education qualification and disability certificates is correct as per service rules. In the event of any information subsequently found to be factually or erroneous or mis-represented, the promotion so granted shall be withdrawn immediately without giving any notice or assigning any reason. Hence, such promotion order is subject to review/cancellation in case of any discrepancy regarding eligibility is found at any stage.
3. That this promotion is subject to the condition that no adverse remarks regarding integrity are found in his/her special ACR and latest NOC also. His/her promotion is subject to the condition of final outcome of Apex Court/High Court decision if any pending or filed.
4. In case, it transpires at any stage that the teacher is ineligible for this promotion, the teacher will be reverted to his/her original post without giving any notice.
5. That her seniority in PwD Quota will be determined as per instructions/ rule issued from time to time by Government of Haryana/ Department.
6. The benefit of reservation in promotion to the employees with disability is only entitled from the date of submission of his medical certificate of disability to the department in accordance with chief secretary Haryana instruction clarification number 22/202/2017-2 GSIII issued on dated 1 January 2018.

7. She is directed to provide latest disability certificate/UDID issued on Swavlambancard.gov.in portal within 30 days failing which, they will be reverted back without giving any notice.
8. The teacher will not be entitled for any arrear till the date of this order.


