Whereas Sh. Gurmel Singh (001867), Retired Headmaster (Elementary School), who served at Government Senior Secondary School, Chhapra (154), Ambala, was erroneously promoted to the post of Elementary School Headmaster (ESHM).

Upon scrutiny of his service records, it has been observed that he did not fulfill the eligibility criteria prescribed under the Haryana School Education (Group C) State Cadre Service Rules, 2012, as he had secured 45.42% marks in B.A., which is below the required 50% minimum qualifying marks.

Moreover, he also did not meet the qualification norms stipulated under the National Council for Teacher Education (Amendment) Act, 2019, which came into effect on 17th August 1995.

In view of the above, it has been decided to revert Sh. Gurmel Singh to his previous post of TGT (Social Studies) with immediate effect.






