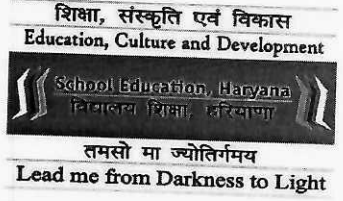

Whereas Sh. Yogesh Kumar [100022], JBT GHS Saunda District Ambala was charge sheeted under rule-7 by DEEO Ambala vide order No. E-2/2016/216-19 dated 11.05.2016 alleging that he remained wilful absent and due to this, the study of students suffered. Charged official Sh. Yogesh Kumar, JBT submitted his reply and requested many times through various representations to DEEO Ambala to allow him to join the duties. Ultimately, the delinquent Sh.
