1. That he will not be entitled to the fixed medical allowances w.e.f. 14.05.2025 and after the date of change of option the allowances will have to be deposited in Government treasury.
2. The medical certificate will be reviewed after a period of five years.
3. The reimbursement will be made only for chronic diseases which have been declared by the Haryana Government.


