**Subject: - Extension of last date for submission on 134-A Arrear Portal, update of contact information, guidelines on recognition documents, and applicable reimbursement rates.**

Kindly refer on the subject cited above.

Some schools raised a grievance through the helpline number as well as via email, stating that schools temporarily blocked on the MIS Portal due to RTE-related reasons could not update their registered contact details. Consequently, they were unable to receive the OTP sent to the MIS-registered mobile number, which is mandatory for logging into the 134-A arrear portal.

**After due consideration of this genuine concern, the department has made the following decisions:-**

1. The last date for submission on the 134-A arrear portal has been extended up to 20.08.2025.
2. An amendment has been made on the MIS Portal to allow temporarily blocked schools to update their contact information.
3. Private schools must carefully review their uploaded recognition certificates on 134-A Arrear Portal. **The classification of documents must be strictly adhered to as per the following guidelines:**

Valid Documents for Recognition Purposes	Invalid Documents for Recognition Purposes
No Objection Certificate (NOC) / Deemed Recognition or Temporary Recognition issued by the Department, which is valid, up-to-date, and renewed on a year-to-year basis.	Affiliation/permission certificates issued by any education board shall not be treated as valid documents for recognition purposes.
Permanent Recognition Certificates issued by the Department.

2. Carefully verify their uploaded recognition certificates as per the prescribed classification.
3. Cross-check their reimbursement amount claimed against the applicable rates given above. If any discrepancy is found between the reimbursement amount summary raised by the school and the applicable rate list, the same must be immediately intimated via email as well as on the helpline number 0172-5049801.

All schools must ensure completion of these steps and timely submission of claims on the arrear portal within the extended deadline.


