

Whereas, Sh. Kulbir Singh, [1028638] JBT, GPS Model Town (Hisar) has filed an appeal against the order No. E-III-2019/06-10 dated 03.10.2020 passed by District Elementary Education Officer, Hisar vide which his services were terminated.

Thereafter Sh. Kulbir Singh, [1028638] JBT, GPS Model Town (Hisar) was granted a personal hearing on 11.09.2025 at 12.00 Noon. The official Sh. Kulbir Singh, [1028638] JBT, GPS Model Town (Hisar) appeared before the undersigned for personal hearing and submitted his representation in writing with various documents and also explained his position verbally. He has also submitted an affidavit he will abide by the decision of the Hon'ble High Court of Punjab and Haryana in the appeal.

Accordingly, the matter has been examined and it is found that due to involvement in FIR No. 168 dated 08.05.2015, he was sentenced for life imprisonment by the Additional Session Judge, Hisar vide order dated 30.01.2019. Thereafter, he filed an appeal against the orders of Ld. Additional Session Judge, Hisar in the Hon'ble High Court of Punjab and Haryana. The Hon'ble High Court vide its order dated 04.02.2025 has granted the bail to him and suspended the sentence of imprisonment during the pendency of appeal.

In view of the bail granted by the Hon'ble Punjab and Haryana High Court, the appeal filed by Sh. Kulbir Singh, [1028638] JBT is hereby accepted. He is allowed to join his duties at GGPS Mangali [12825] Hisar subject to final outcome of the decision of the Hon'ble Punjab and Haryana High Court in the appeal filed by him.
