Whereas Sh. Suresh Kumar, Head Teacher, GPS Sanpur (Rohtak) was compulsorily retired from service vide this office order No. 5/69-2021 D&L (2) dated 25.09.2024/26.09.2024. The delinquent, Sh. Suresh Kumar, Head Teacher, GPS Sanpur (Rohtak) filed an appeal through his representation with a request to reinstate him in service and requested to grant him personal hearing. Considering his request, he was granted an opportunity of personal hearing to explain his position on 25.09.2025.

On 25.09.2025, the delinquent Sh. Suresh Kumar, Head Teacher, GPS Sanpur (Rohtak) appeared and submitted his written statement alongwith relevant documents explaining his position in detail. He has stated that he may be reinstated in service in view of the decision dated 10.02.2025 passed by the Hon'ble High Court of Punjab and Haryana in CRR No. 11 of 2016 (O&M).

Accordingly, the matter was considered and after going through the facts, circumstances of the case and in view of acquittal from Hon'ble High Court as well as quashing of the orders of Ld. Additional Session Judge and Ld. JMIC Rohtak by the Hon'ble High Court, it is decided to withdraw the office order No. 5/69-2021 D&L (2) dated 25.09.2024/26.09.2024 and reinstate Sh. Suresh Kumar, Head Teacher back in service with immediate effect. 

Whereas Sh.
