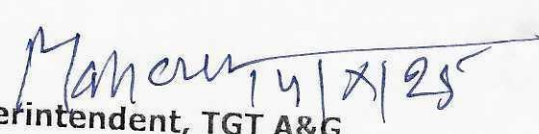

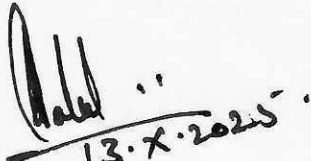

Whereas, Sh. Sanjay Kumar, [1007852] JBT, GPS Karontha (Rohtak) has filed an appeal against the order No. E-3-2020/599-604 dated 18.05.2020 passed by District Elementary Education Officer, Rohtak vide which his services were dismissed.

Thereafter Sh. Sanjay Kumar, [1007852] JBT, GPS Karontha (Rohtak) was granted a personal hearing on 19.09.2025 at 12.00 Noon. The official Sh. Sanjay Kumar, [1007852] JBT, GPS Karontha (Rohtak) appeared before the undersigned for personal hearing and submitted his representation in writing with various documents and also explained his position verbally by narrating family circumstances also. He has also submitted an affidavit that he will abide by the decision of the Hon'ble High Court of Punjab and Haryana.

Accordingly, the matter has been examined and it is found that due to involvement in FIR No. 521 dated 19.10.2008, he was sentenced three years imprisonment by the JMIC Karnal vide order dated 08.10.2013/10.10.2013. His appeal filed before the Ld. Additional Session Judge, Karnal was rejected on 09.12.2014. Thereafter, he filed an appeal/ revision petition in the Hon'ble High Court of Punjab and Haryana. The Hon'ble High Court vide its order dated 27.07.2015 has suspended the sentence during the pendency of the revision petition. Now the Hon'ble High Court has decided the said revision petition vide its judgement dated 01.09.2025, wherein, he has been released on probation.

In view of the orders passed by the Hon'ble Punjab and Haryana High Court, the appeal filed by Sh. Sanjay Kumar, [1007852] JBT, GPS Karontha (Rohtak) is hereby accepted. He is allowed to join his duties in district Rohtak.

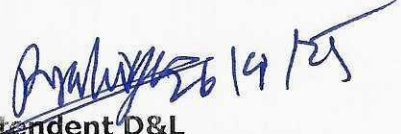
