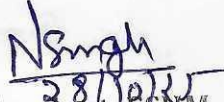

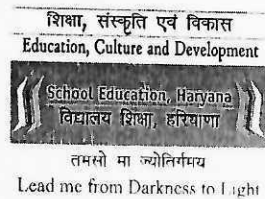

Whereas Smt. Halima widow of Late Sh. Abdul Karim, Head Teacher Govt. Middle School, Gheera Punhana (Nuh) filed CWP No. 412 of 2023 titled as Halima Vs. State of Haryana and others praying therein for quashing speaking order dated 05.12.2022 (Annexure P-12) whereby the claim of the petitioner with regard to release the compassionate financial assistance under rule 26 of Haryana Civil Services (Compassionate Financial Assistant or Appointment) Rules 2019 has been rejected.

And whereas, the aforesaid writ petition was disposed of by the Hon'ble High Court vide its directions dated 28.07.2025 and the same are re-produced as under:-

"This is an application under Section 151 CPC seeking permission to withdraw the present petition in view of compromise dated 19.05.2025 entered in to between the petitioner and respondent No.5.

Learned counsel for the State has no objection to the prayer made by the petitioner. Learned State counsel contends that the pending joint representation of the parties, Annexure A-4, will be decided in accordance with law within a period of three months.

On joint request of learned counsel for the parties, main case is taken on Board.

In view of above, application is allowed, and the present petition stands dismissed as withdrawn.

In compliance of above directions of the Hon'ble High Court dated 28.07.2025 passed in the above CWP, the joint representation dated 19.05.2025 (Annexure A-4) has been duly examined and the petitioner and Smt. Noornisa in their joint representation have requested to release all admissible service benefit, dues and entitlements (including compassionate assistance under the Haryana Civil Services Rules, gratuity, leave encashment, GPF etc.) in favour of both of them jointly.

And whereas, after examining the joint representation made by both the wives of the deceased govt. employee i.e. Late Sh. Abdul Karim, Head Teacher, it has been found that there was some dispute regarding succession and the entitlement to the benefits of compassionate financial assistance and other service benefits. However, all such dispute has now been amicably resolved, and a Compromise Deed dated 19.05.2025 has been duly executed between them, outlining the mutual terms of settlement. As per the said compromise, both the parties have agreed to receive the financial/service benefits of the deceased employee jointly and to share such benefits equally or as per mutually agreed terms.

And whereas, the following provision has been made in rule 26 of HCS (CFA&A) Rules, 2019 regarding Compassionate financial assistance to widows more than one in equal shares and the same is re-produced here as under:-

“Where a deceased Government employee is survived by more than one widow, where personal law permits, the compassionate financial assistance shall be payable to the widows in equal shares upto the date of prescribed period or ineligibility, whichever is earlier. When one of them becomes ineligible for compassionate financial assistance, her share of the compassionate financial assistance shall become payable to her eligible child, if any :

Provided that if any child of such widow is not eligible for compassionate financial assistance, the share of the compassionate financial assistance shall not lapse but shall be payable to the other widow(s) in equal shares.

Note.—The provision of this rule shall not be applicable to Hindu Government employee because any second marriage after the commencement of Marriage Laws (Amendment) Act, 1976 during the lifetime of his first wife is a nullity and have no legal effect. Such second marriage cannot be valid on the ground of any custom. In fact, a custom opposed to an expressed provision of law have no legal effect. So, the second wife shall not be entitled to the compassionate financial assistance as a legally wedded wife”

From the perusal of the above rules, it is clear that both the wives (Smt. Noornisa and Smt. Halima) of the deceased employee are entitled to get an amount of ex-gratia grant and compassionate financial assistance in equal share. District Elementary Education Officer, Nuh is directed to submit the above cases alongwith documentary proof to this Directorate within a period of 3 days positively through special messenger of his office.

So far as the case of the family pension is concerned, the following provision has been made in Rule 57 of Haryana Civil Services (Pension) Rules, 2016 regarding family pension to more widows than one in equal shares and the same is re-produced here as under:-

Where a deceased Government employee is survived by more than one widow if permissible under personal law, the family pension shall be payable to the widows in equal shares upto the date of eligibility. When one of them becomes ineligible for family pension, her share of the family pension shall become payable to her eligible child, if any: Provided that if any child of such widow is not eligible for family pension, the share of the family pension shall not

lapse but shall be transferred to the other widow(s) in equal shares or if there is only one such other widow, in full, to her.

Note 1.— The minimum ceiling of family pension shall not be applicable on the share of family pension admissible under this rule.

Note 2.— The provision of this rule shall not be applicable to Hindu Government employee because any second marriage after the commencement of Marriage Law (Amendment) Act, 1976 during the lifetime of his first wife is a nullity and have no legal effect. Such second marriage cannot be valid on the ground of any custom. In fact, a custom opposed to an expressed provision of law is of no legal effect. So, the second wife shall not be entitled to the family pension as a legally wedded wife.

From the perusal of the above rules, it has been found that the family pension is to be equally paid to both the wives of Late Sh. Abdul Karim, Head Teacher after the expiry of the period of compassionate financial assistance. District Elementary Education Officer, Nuh is directed to ensure that their family pension case complete in every respect will be submitted to the office of Principal Accountant General (A&E), Haryana, Chandigarh by the DDO of the concerned School immediately through special messenger of their office.

So far as the payment of amount of Death-cum-Retirement Gratuity is concerned, the family means for the purpose of Death-cum-retirement Gratuity as provided in rule 8 (10) (A) (1) (a) of HCS (Pension) Rules, 2016 and the same is re-produced here as under :-

“1(a) wife or wives (wherever permissible under personal law) including judicially separated wife or wives, in the case of the male Government employee”.

De / From the perusal of the above rules, it has been found that the amount of DCRG is to be equally paid to both the wives of Late Abdul Karim, Head Teacher. District Elementary Education Officer, Nuh is further directed to ensure that DCRG case complete in every respect will be submitted to the office of Principal Accountant General (A&E) Haryana, Chandigarh by the DDO of the concerned School immediately through special messenger of their office.

So far as the claim regarding payment of amount of General Provident Fund is concerned, it is clarified that nomination made by the deceased Govt. Employee to Smt. Noornisa has become now invalid in the changed circumstances of this case. The following provision has been made in **Rule 17**, regarding "**Events when nomination becomes invalid** of HCS (GPF) Rules, 2016 and the same are re-produced here as under:-

Rule 17 *"A nomination shall become invalid in the event of the happening of a contingency specified therein; Provided that if at the time of making the nomination, the subscriber has-*

- (i) no family; or*
- (ii) only one member of the family,*

he shall provide in the nomination that the right conferred upon the alternate nominee under rule 16 shall become invalid in the event of his subsequently acquiring family or other member (s) in his family, as the case may be."

From the perusal of the above rules, it reveals that the nomination made by the deceased employee while in service for the payment of amount of General Provident Fund showing Smt. Noornisa as nomination has now become invalid in view of compromise deed dated 19.05.2025 and in terms of the directions dated 28.07.2025 passed by the Hon'ble Punjab & Haryana High Court, Chandigarh in CWP no.412 of 2023 titled as Halima Vs State of Haryana & others and both the wives (Smt. Noornisa and Smt. Halima) of the deceased employee are entitled to get an amount of GPF in equal share.

Further claim of both the wives of the deceased employee regarding payment of an amount of leave encashment is concerned, although, there is no specific mention regarding equal distribution of the same in the Haryana Civil Services (Leave) Rules, 2016. However, in the light of the compromise deed dated 19.05.2025 made by both wives of the deceased employee and in terms of the directions dated 28.07.2025 passed by the Hon'ble Punjab & Haryana High Court, Chandigarh in CWP no. 412 of 2023 titled as Halima Vs State of Haryana & others, an amount of leave encashment be paid in equal share to both of them (Smt. Noornisa and Smt. Halima wives of the deceased employee) by the District Elementary Education Officer, Nuh being the appointing authority of deceased employee.

After going through the relevant record of the case, the rules mentioned above and examining a joint representation dated 19.05.2025 (Annexure A-4) made by both the wives of the deceased employee, it has been found that the payment of the amount of Ex-gratia grant, compassionate financial assistance, family pension, death-cum-retirement gratuity, final payment of GPF and leave encashment etc. will be released to both the wives (Smt. Noornisa and Smt. Halima) in equal shares in the light of compromise deed dated 19.05.2025 made by both of them and in terms of Hon'ble Punjab & Haryana High Court, Chandigarh directions dated 28.07.2025 passed in CWP no.412 of 2023 titled as Halima Vs State of Haryana & others.

I, therefore, pass an order accordingly.
