Whereas, Smt. Saroj Mehra [047611], Principal, Government Senior Secondary School, Pabnera [3527] Sonapat was charge-sheeted under Rule-8 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/182-2021 HRG-I(1) dated 24.01.2025 and the following charges were leveled against her:-


That District Education Officer, Sonapat constituted three members committee to enquire into the complaints made by Pardeep Kumar, Village Pabnera, Sonapat on CM Grievance portal vide No. CMOFF/N/2023/105084 & CMOFF/N/2023/104987 dated 21.08.2023 & 18.08.2023 respectively and District Education Officer, Sonapat submitted report vide letter no. E-7/2023/25 dated 29.09.2023. On examination of the aforesaid report, the following irregularities were found to be committed by you i.e. Smt Saroj Mehra while being working as Principal:-

1. That your behavior as principal is not good with staff and the resident of village and you are habitual in refusing to attest certificates in time i.e. School Leaving Certificate, Bank Account, Character Certificate, etc and thus, the benefit of the schemes of the government was not being extended to the beneficiaries. Further, you failed to follow the guidelines for celebration of Independence day celebration on 15.08.2023.
2. That School Management Committee was constituted on 21.07.2023 which was overwritten by you to be constituted on 20.07.2023 although you were on leave on 20.07.2023. Further, you failed to improve basic infrastructure of the school. Furthermore, toilets and drinking water facility was not found good.

That charged officer submitted reply to the charge sheet and denied all the charges levelled against her. Thereafter, she was granted an opportunity of personal hearing by Director Secondary Education on 08.08.2024 and finding her reply not satisfactory punishment of stoppage of one increment without cumulative effect was inflicted upon her vide order dated 11.09.2024. Aggrieved from the order dated 11.09.2024, Smt. Saroj Mehra preferred appeal dated 24.10.2024. Accordingly, she was granted an opportunity of personal hearing on 30.07.2025 by the undersigned.

The documents available on the file were examined and undersigned heard the charged officer & the representative of the department. The office has not been able to point out what difference would be there if the date of SMC meeting was not changed from 21.07.2023 to 20.07.2023. Further, no administrative or financial issue has been pointed out. Keeping this in mind, the order passed by Director Secondary Education is set aside and the charge sheet against the charged officer is dropped. She be warned to be careful in future.

It is ordered accordingly.

Whereas, the petitioner had filed the Civil Writ Petition No. 30201 of 2025 titled as "Rajender Kumar vs. State of Haryana & Others" before the Hon'ble Punjab and Haryana High Court at Chandigarh praying therein to count the service from 01.09.1998 against the sanctioned post of peon followed by regularization of service of the petitioner from 20.08.2014 without any breaks and thereby giving the benefit of the consequential benefits in respect to seniority, promotion, gratuity and pensionary benefits to the petitioner as per the law as laid down by Full Bench of the Hon'ble Punjab and Haryana High Court in Kesar Chand versus State of Punjab through the Secretary P.W.D.B. & R Chandigarh and others 1988 AIR Punjab and Haryana 265 in the interest of justice.


The above said writ petition came up for hearing on 13.10.2025, and on that day, the same was disposed of by the Hon'ble Court with the direction to decide the legal notice of the petitioner. The operative part of the said order is as under:-

Notice of motion.

4. Mr. Amit Sahni, Additional Advocate General, Haryana, accepts notice and submits that the pending legal notice, dated 14.08.2025, will be decided by respondent no.3/Director, School Education Department, in the light of Kesar Chand case ibid, by passing a speaking order in accordance with law, within three months.

5. In view of the statement made, learned counsel for the petitioner has no objection to the petition being disposed of in terms thereof.

6. Ordered accordingly.



7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹50,000 to the petitioner.

In compliance of the above said direction of the Hon'ble High Court, the case record and legal notice dated 14.08.2025 of the petitioner was examined. After due examination of the matter, it has been found that the petitioner was initially engaged as Part time class-IV employee in GPS Dhani Mahu District Bhiwani on 01.09.1998 as per the prevailing DC rates only for three and half hours per day. The service of the petitioner was regularized on 20.08. 2014 as per recommendation dated 06.08.2014 vide memo no. 22/76-2011 HRME (5) made by Directorate in light of the policy dated 11.11.2003 on the basis of his seniority as well as eligibility as and when sanctioned post was available in the school subject to the fulfilment of the terms and conditions of the policy dated 11.11.2003.

Further, it is relevant to mention here that as per policy dated 11.11.2003, the District Education Officer, Bhiwani prepared a common seniority list at District level of all the Class-IV employees working in Govt. Primary/Middle/High/Senior Secondary School and field offices like o/o BEOs/DEOs/DPEOs etc. as on 30.06.2003 for regularization of their services against vacant regular sanctioned post. As per district level seniority list the petitioner stood at serial number 677 & hence he was regularized in the year 2014 as per his entitlement.

Whereas, as per State Government Notification dated 18.08.2008 of Finance Department of Government of Haryana, New Pension Scheme came-in-to force, which is applicable to the employees, who has joined as a regular employees on or after 01.01.2006.

Further, as per Rule 3.17-A(g) (iii) of Punjab Civil Service Rules Volume-II, the service period rendered as "PART TIME" employee cannot



be computed for pension & pensioner benefits. Relevant portion of the same is reproduced as under.

Rule 3.17 A (g): The entire service rendered by an employee as work charge shall be reckoned towards retirement benefits provided:-

(1) Such service is followed by regular employment.

(2) There is no interruption in the two or more spells of services or the interruptions fall with-in condonable limits: and

(3) Such services is a whole time employment and not part-time or portion of day.

In view of the above-mentioned facts, the case of the petitioner cannot be considered under Old Pension Scheme as the petitioner was entitled for regularization from 20.08.2014, therefore he is entitled to get the benefits of New Pension Scheme which was prevalent at the time of regularization of the petitioner and accordingly, the benefits of New Pension Scheme have already been granted/released to the petitioner. Further, for the purpose of getting benefits under the Old Pension Scheme, the person has to serve as a regular employee within the prevalence of Old Pension Scheme and the same was discontinued from 01.01.2006 onwards and the petitioner was regularized after the said date. Therefore, he is not entitled to get the benefits of Old Pension Scheme.

Thus, the petitioner had joined as a regular employees after 01.01.2006 i.e. in the year 2014. So, New Pension Scheme is applicable to the petitioner. Therefore, on the basis of "NEW PENSION SCHEME", the PRAN number was allotted to him and he had also deposited his share in his NPS account. In this manner, the General Provident Fund attached to Old Pension Scheme is not applicable in the case of the petitioner.

Therefore, keeping in view the above said facts & circumstances of the case, the claim of the petitioner demanded through legal notice dated 14.08.2025 (Annexure P-5) is not tenable & hence liable to be rejected.

I order accordingly.
