Whereas, the present CWP No. 22699 of 2025 Anil Kapoor and another Vs. State of Haryana & Others was filed in the Hon'ble High Court praying therein for directing, the respondent-Department for stepping up his pay at par with respondent No.3, who is very much junior to the petitioners and getting more salary as compared to the petitioners. Further directing the respondent department to decide his representation submitted to the respondent department dated 09.04.2025 by the petitioners.

The said writ petition came up for hearing before the Hon'ble High Court on 06.08.2025 and Hon'ble High Court was pleased to dispose of the present writ petition. The operative part of the order is reproduced as under:-

3. Notice of motion.

4. Mr. Amit Sahni, Additional Advocate General, Haryana, accepts notice on behalf of the respondents/State, and submits that the pending representation, dated 09.04.2025, will be decided by respondent no.2/Director, Elementary Education, by passing a speaking order in accordance with law, within a period of three months.

5. In view of the statement made, learned counsel for the petitioners has no objection to the petition being disposed of in

terms thereof.

"

6. Ordered accordingly.

7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹50,000 to the petitioners."

In the compliance of above direction, the representation dated 09.04.2025 of the petitioners has been examined. After examining the case of the petitioners, it has been found that Sh. Anil Kapoor and Sh. Ashok Kumar were appointed on the post of Mathematics Master on dated 01.01.1991 (regular). The petitioner No. 1 Sh. Anil Kapoor was promoted as ESHM on 13.06.2013 and Petitioner No. 2. Sh. Ashok Kumar was also inadvertently promoted on 17.06.2013. The Educational Qualification details of the petitioners are as under:-

Whereas, the educational qualifications for the post of Elementary School lead Master are mentioned in Appendix-B of the Haryana School Education (Group C) State Cadre Service Rules, 2012. In the Haryana School Education (Group C) State Cadre Service Rules, 2012, it is clearly stated that no employee who is on the post of TGT is exempted from requirements provided under Appendix B of Rules, 2012 for promotion as Elementary School Head Master (ESHM) which are as under:

Whereas, above mentioned table clearly depicts that for the promotion of Elementary School Headmaster, in this case an employee must have 50% marks in his graduation however, both the petitioners had marks lower than 50% in their graduation which is lower than the qualifying marks for the promotion of ESHM. Further, it is relevant to mention here that the department is bound by the Law, Rules, Regulation, Instructions, Notification and Decision passed by the Hon'ble Apex Court. However, the representationist demand notice/representation is

found to be devoid of merits as per the Haryana School Education (Group C) State Cadre Service Rules, 2012 (Appendix - B) as the representationist failed to match the qualification criteria fixed at the time of their promotion as per Rules, 2012. The above mentioned rules clearly depicts that the representationist are not entitled for the promotion of ESHM.

Moreover, regarding the inadvertent promotion of representationist to the post of ESHM, the Department of Education has issued the Show Cause Notice to both the petitioners on 29.01.2019 and further issued reversion order dated 21.08.2019. The said reversion order was stayed vide order dated 30.08.2019 by Hon'ble Division Bench in the CWP No. 23248 of 2019 titled as Virender Khangwal and others Vs. State of Haryana and others. But still the fact is that the petitioners are ineligible for the promotion to the post of ESHM. In such circumstances, if they are allowed to draw pay equivalent to respondent no. 3 then it would be a burden on state exchequer.

Accordingly, in the light of above-mentioned facts, request for stepping up of their pay at par with their junior counterpart that respondent No. 3 Sh. Yad Ram is unjustified for the reasons stated above. It is hereby directed that the claim made in their representation dated 09.04.2025 is not maintainable as per record and hereby rejected.
