Whereas, the names of the 47 (Rest of Haryana Cadre) and 01 (Mewat Cadre) selected candidates have been recommended by the Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Physical Education** vide recommendation no. RG-15/2024/14696 dated 11.02.2025 against Advt. No. 30/2024. While, recommending the name of the selected candidate, the HSSC, Panchkula had made an observation as under:-

“The Commission has interviewed and recommending the above candidate on the basis of the photocopies of documents submitted by them alongwith their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission.”

Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 22.02.2025, but the following 05 candidates remained absent during the verification of documents:-

Thereafter, opportunities on website were again given for verification of documents by the department on 08.05.2025, but these candidates again failed to appear before document verification committee.

Keeping in view of the above, I have come to the conclusion that the above mentioned candidates are not willing to serve as PGT Physical Education as they have failed to appear before Document Verification

Committee for verification of their documents despite giving appropriate opportunities.

In view of the above, it has been decided to cancel their candidature for the post of PGT Physical Education. However, before cancellation of their candidature, a notice is hereby served upon them, as to why their candidature be not cancelled. Reply, if any, they want to file in response to this notice may be filed in the office of Director Secondary Education, Haryana, Panchkula and through E-mail i.e. dsepgt1@gmail.com not later than 15 days from the date of this notice. In case, they fail to respond to the notice within a stipulated period, it shall be presumed that they have nothing to say/submit in this regard and their candidature will be cancelled.
