**Dated, Chandigarh, the 29.12.2025**

Whereas, the names of the 43 selected candidates have been recommended by the Haryana Public Service Commission, Panchkula for appointment to the post of PGT **Sanskrit** for Mewat Cadre vide recommendation No. RG-15/2024/14658 dated 07.02.2025 against Advt. No. 34/2024. While, recommending the names of the selected candidates, the HPSC, Panchkula had made an observation as under:-

***“The Commission has interviewed and recommending the above candidates on the basis of the photocopies of documents submitted by them alongwith their online application form. The documents of the candidates have not been verified by the Commission. Therefore, before giving offer of appointment to the candidates, all the original Degree/Certificates may be verified to ensure that they fulfills all conditions of Education Qualifications, Age and Category etc. as prescribed for the post in the requisition and relevant Service Rules. The recommended candidates have also not been Medically Examined and no special enquiry into their Antecedents have been made by the Commission.”***

Accordingly, Document Verification Committees were constituted to verify the documents and all the recommended candidates were called for verification of their documents on 23.02.2025. After completing the due process, appointment letters were issued to 42 eligible candidates who were appeared before document verification committee vide appointment order dated 04.04.2025 & 12.11.2025 and directed to join within 15 days at allotted station. The candidate namely Smt. Priyanka D/o Sh. Shish Ram Singh bearing Roll No. 3705 not joined her duties within stipulated period. Furthermore, no request for extension in joining period has been received from her.

Keeping in view of the above, I have come to the conclusion that the above mentioned candidate namely Smt. Priyanka D/o Sh. Shish Ram Singh bearing Roll No. 3705 is not willing to serve as PGT Sanskrit for Mewat Cadre against Advt. 34/2024 as she was failed to join her duties and no request for joining received from her.

In view of the above, it has been decided to cancel her candidature for the post of PGT Sanskrit for Mewat Cadre against Advt. 34/2024. However, before cancellation of her candidature, a final opportunity is

granted to her to join duties within 15 days (till 29.01.2026) otherwise her appointment/candidature will be cancelled. No further opportunity will be granted.


