

The above promotions subject to the following terms and conditions:-

1. That this promotion is subject to condition of refixation of seniority/fixing the roster point. If any official is found senior to him/her at any stage due to refixation of his/her seniority/roster wise point, he/she shall be reverted without giving any notice. Also if, any senior employees is found entitled for promotion he/she will be eventually promoted by the department by virtue of his entitlement for promotion.
2. That this promotion is subject to condition that all the particulars and data supplied by concerned employee and field office is correct. In the event of any information subsequently found to be factually or erroneous or misrepresented, the promotion so granted shall be withdrawn immediately without giving any notice or assigning any reason.
