Whereas Sh. Suresh Kumar (1001050), TGT Punjabi, GHS Thamber (167) District Ambala was promoted vide memo no. 17/16-2024 TGT Pro (2) dated 23.08.2024 w.e.f. 17.02.2020. Now upon considering his representation, the antedated promotion date on the post of TGT Punjabi o said teacher may be treated as 30.07.2018 instead of 17.02.2020 with benefit of notional pay fixation/seniority not monetary benefits (arrears). 3. The JBTs appointed in Year 2000 and 2011 whose recruitment/appointment is disputed. Before joining on the promotional post school incharge/DEEO concerned ensure that no disciplinary proceedings pending against teacher in this regard.

5. In case, it transpires at any stage that the teacher is ineligible for this promotion, the teacher will be reverted to his/her original post without giving any notice.
