Order No. 17/41-2025 ESHM (2)

Whereas, the present CWP No. 16487 of 2025 Kailash Chander and others Vs. State of Haryana & Others was filed in the Hon'ble High Court praying therein for directing, the respondent to Step-up the pay of the petitioners equal to their junior counterparts notionally from the date when they were promoted as ESHM's and actually from the date the petitioners have joined as ESHM. The same be directed to be released along with interest @ 18 percent per annum from the date it fell due till the date of its realization.

The said writ petition came up for hearing before the Hon'ble High Court on 29.05.2025 and Hon'ble High Court was pleased to dispose of the present writ petition. The operative part of the order is reproduced as under:-

- 3. Notice of motion.**
- 4. Mr. Harish Rathee, Senior Deputy Advocate General, Haryana, accepts notice on behalf of the respondents/State and submits that the pending legal notice, dated 01.04.2025, will be decided by respondent no.3-Director, Elementary Education, by passing a speaking/reasoned order in accordance with law within a period of three months.**
- 5. In view of the statement made, learned counsel for the petitioners has no objection to the petition being disposed of in terms thereof.**
- 6. Ordered accordingly.**
- 7. In case the order is not passed within the stipulated period, the officer concerned shall pay costs of ₹50,000 to the petitioners."**

In the compliance of the above directions, the legal notice dated 01.04.2025 of the petitioners have been examined and it is found that petitioner no. 1, 6 and 8 are under administrative control of respondent no. 3 being Elementary School Headmasters whereas petitioner no. 2, 3, 4, 5 and 7 are under respondent no. 2 i.e. Department of Secondary Education and their claim for stepping-up of their pay at par with their juniors is to be decided by Respondent no. 2 being competent authority to do so.

Whereas, after examining the case of the petitioner no. 1, 6 and 8, the petitioner no. 1 and 8 fulfill the requisite Educational Qualifications to the post of ESHM and the benefit of stepping-up has been granted by this department vide order no. 17/41-2025 ESHM(2) dated 13.02.2026. Whereas, petitioner no. 6 does not fulfill the essential qualification as prescribed in appendix-B of Haryana School Education (Group-C) State Cadre Service Rules, 2012. The details of these petitioners are as under:-

Whereas, the educational qualifications for the post of Elementary School Head Master are mentioned in Appendix-B of the Haryana School Education (Group C) State Cadre Service Rules, 2012. In the Haryana School Education (Group C) State Cadre Service Rules, 2012, it is clearly stated that no employee who is on the post of TGT is exempted from requirements provided under Appendix B of Rules, 2012 for promotion as Elementary School Head Master (ESHM) which are as under :-

Whereas, above mentioned table clearly depicts that for the promotion of Elementary School Headmaster, in this case an employee must have 50% marks in his graduation however, the petitioner no. 6 Sh. Nishan Singh had marks lower than 50% in their graduation which is lower than the qualifying marks for the promotion of ESHM. Further, it is relevant to mention here that the department is bound by the Law, Rules, Regulation, Instructions. The petitioner no. 6 demand notice is found to be devoid of merits as per the Haryana School Education (Group C) State Cadre Service Rules, 2012 (Appendix - B) as the petitioner no. 6 failed to match the qualification criteria fixed at the time of their promotion as per Rules, 2012. Once the petitioner no. 6 is not eligible for the promotion and promoted inadvertently, the claim of pay fixation is not maintainable.

Accordingly, in the light of above-mentioned facts, request for stepping up of his pay at par with his junior counterpart Sh. Ramesh Kumar is unjustified for the reasons stated above. It is hereby directed that the claim for the petitioner no. 6 Sh. Nishan Singh made in this Legal Notice dated 01.04.2025 is not maintainable as per record and hereby rejected. However, benefit of stepping-up w.r.t. petitioner no. 1 Sh. Kailash Chander and petitioner no. 8. Sh Navneet Kumar have already been sanctioned vide order No. 17/41-2025 ESHM(2) dated 13.02.2026.

I order accordingly.
