

2. Other terms and conditions regarding station allotment will remain same.





Ganander Singh (1000251), JBT who possess the requisite qualification of TGT Mathematics is hereby provisionally promoted with benefit of notional pay fixation/seniority not monetary benefit (arrears) against the post of TGT Mathematics HES-III (School Cadre) w.e.f. 13.08.2024 in the pay matrix FPL-7 (44900-142400)+usual allowances as sanctioned by the Haryana Government from time to time in officiating capacity. The above promotions subject to the following terms and conditions:-

1. That this promotion is subject to condition of refixation of seniority/fixing the roster point. If any official is found senior to him/her at any stage due to refixation of his/her seniority/roster wise point, he/she shall be reverted without giving any notice. Also if, any senior employees is found entitled for promotion he/she will be eventually promoted by the department by virtue of his entitlement for promotion.
2. That this promotion is subject to condition that all the particulars and data supplied by concerned employee and field office is correct. In the event of any information subsequently found to be factually or erroneous or misrepresented, the promotion so granted shall be withdrawn immediately without giving any notice or assigning any reason. Hence, such promotion order is subject to review/cancellation in case of any discrepancy regarding eligibility is found at any stage.
3. The JBTs/PRTs appointed in Year 2000 & 2011 whose recruitment/appointment is disputed. His/her promotion is subject to the condition of final outcome of Apex Court/High Court decision, if any.
4. That this promotion is subject to the condition that no adverse remarks regarding integrity are found in his/her special ACR and latest NOC till today.
5. In case, it transpires at any stage that the teacher is ineligible for this promotion, the teacher will be reverted to his/her original post without giving any notice.
6. In case of eligibility of any teacher in more than one subjects, in this situation before joining, teacher will give his/her undertaking to school incharge that he will not claim for his promotional subject to be changed in



- future or antedated promotion in any other subject. In case the candidate is not willing to join on the said promotional post and he wants the promotion on other subject then the candidate will give his representation through proper channel in the Directorate.
7. The posting order of the newly promotee shall be issued separately later.




