The appointment is subject to the following terms and conditions:

1. The candidates are appointed purely on provisional/temporary basis. This appointment is against temporary post and their confirmation against



substantive post shall be considered on the basis of their seniority, record of service and as and when such post is available.

2. The candidates shall have to take an oath of allegiance to the Constitution of India before issuance of regular appointment letter.
3. The candidates shall not claim seniority on the basis of this order. Their inter-se seniority will be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time.
4. The appointment will be subject to the final outcome of the pending court case(s), if any.
5. The candidates shall remain on probation for a period of two years, extendable upto three years as per rules 27 of HCS (General) Rules, 2016.
6. In the matters, not specifically mentioned in this communication, the candidates shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
7. In case of reserved category candidates, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then their service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
8. The candidates shall be governed by the Haryana State Education School Cadre (Group-C) Service Rules, 2012 (amended from time to time).
9. No TA/DA will be admissible to the candidate for joining as TGT.
10. If at any time during the course of their temporary appointment, they desire to resign, then in such eventuality, they shall be required to give one month's notice or forfeit, in lieu thereof, their one month's salary including allowances etc.
11. If they get an appointment as TGT on the basis of their furnishing ineligible/invalid qualifications, false/forged or fraudulent information/facts which are detected later on, they would be liable for termination of service without any notice.
12. The appointment is purely provisional and subject to satisfactory police verification and character antecedents, which must be completed within a period of two months from the date of joining; failing which, or in case of any adverse report, the services shall be liable to be terminated forthwith without any notice or compensation.
13. In case of any contradiction between terms & conditions of this appointment letter & statutory rules then in such a case statutory Rules of State Govt. (Govt. of Haryana) as well as of the department shall prevail.
14. Medical Fitness Certificate should be submitted before the joining.
