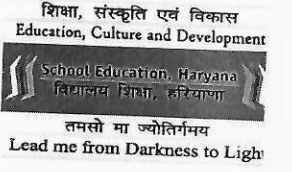



In pursuance of this office order No. 05/112-2021 D&L (3) dated 28.10.2025, a chargesheet was issued against Sh. Sharwan kumar [1020201] TGT Sanskrit, Government High School Deoli [1134], District Palwal, under Rule 7 of the Punishment and appeal Rules in connection with the misbehavior/misconduct and on the basis of the complaint.

Whereas, upon review of the matter, it has been observed that the chargesheet does not contain certain procedural requirements as prescribed during the initiation of the disciplinary proceedings.
