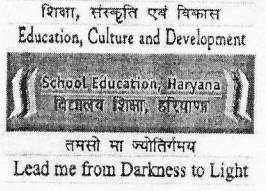

5. If any teacher assigned the duty in census process, then he/she will perform/complete/accomplish the same on priority basis and will be relieved from previous school after completion of said duty accordingly.
