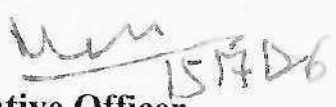

The above promotions subject to the following terms and conditions: -

1. That this promotion is subject to condition of refixation of seniority/fixing the roster point. If any official is found senior to him/her at any stage due to refixation of his/her seniority/roster wise point, he/she shall be reverted without giving any notice. Also if, any senior employees is found entitled for promotion he/she will be eventually promoted by the department by virtue of his entitlement for promotion.
2. That this promotion is subject to condition that all the particulars and data supplied by concerned employee and field office is correct. In the event of any information subsequently found to be factually or erroneous or mis-represented, the promotion so granted shall be withdrawn immediately without giving any notice or assigning any reason. Hence, such promotion order is subject to review/cancellation in case of any discrepancy regarding eligibility is found at any stage.
3. That this promotion is subject to the condition that no adverse remarks regarding integrity are found in his/her special ACR and latest NOC.
4. In case, it transpires at any stage that the teacher is ineligible for this promotion, the teacher will be reverted to his/her original post without giving any notice.

5. In case of eligibility of any teacher in more than one subjects, in this situation before joining, teacher will give his/her undertaking to school incharge that he will not claim for his promotional subject to be changed in future or antedated promotion in any other subject. In case the candidate is not willing to join on the said promotional post and he wants the promotion on other subject then the candidate will give his representation through proper channel in the Directorate.
6. This is purely temporary posting till the teacher transfer drive resume and the teacher will have to participate in upcoming Teacher's Transfer Drive for permanent posting as per their entitlement.
7. No TADA and joining time will be admissible to the teachers.
8. The teacher will be relieved immediately and join at their new station failing which he/she will be liable for disciplinary action.
9. In case there is no vacancy in the allotted School, then DEEO concerned shall immediately inform the Directorate regarding the same. Thereafter DEEO shall ensure attendance in their office and will allot teaching work to that teacher as per workload to avoid "on road" time of teacher in Student- teacher welfare.
10. If any teacher assigned the duty in census process, then he/she will perform/complete/accomplish the same on priority basis and will be relieved from previous school after completion of said duty accordingly. Relieving order will be issued by official concerned only after ensuring that employee is no longer against in census duty.
