Games to be held in the State of Haryana.**

The Department has launched the Student Registration Portal to facilitate the participation of students in on-going school sports activities across the State of Haryana. The portal has been developed to provide a centralized, transparent, and efficient digital platform for registering students from both Government and Private Schools.

The primary objective of the portal is to collect and maintain accurate information related to students' participation in various sports disciplines. In consultation with the Sports Department, the portal captures essential athletic parameters, including the Sports Category, Sport Name, Age Group, and other relevant eligibility details required for participation in school sports competitions.

The online platform enables students and schools to complete the registration process digitally, eliminating the need for manual paperwork and reducing the chances of data entry errors. It also incorporates automated eligibility validation based on predefined criteria, ensuring that only eligible students are enrolled in the appropriate sports categories and age groups.

By digitizing the registration and verification process, the portal enhances transparency, improves data accuracy, streamlines administrative workflows, and enables timely monitoring and management of student participation in school sports across Haryana. This initiative supports efficient planning, better coordination among stakeholders, and the creation of a comprehensive database of student athletes, thereby strengthening the overall administration of school sports in the State.

- School Level (Registration)**

All Government and recognized Private Schools are hereby directed to register the details of eligible students on the dedicated Student Registration Portal for participation in the ongoing School Games in the State of Haryana by **31.07.2026**. It shall be the responsibility of each school to ensure that student information is entered accurately and completely within the stipulated



timeline. The registration must include all prescribed details, including the relevant sports category, sport name, age group, and other required eligibility information, to facilitate verification and participation in the respective school sports competitions.
