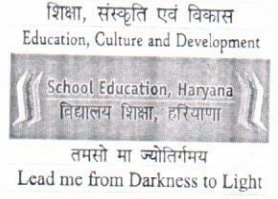

In compliance of Hon'ble High Court order dated 13.02.2026 in CWP No. 26684 of 2025-Madhu Bala vs. State of Haryana and others, the promotion orders issued vide No. 17/17-2020 HRM-I (2) dated 20.02.2020 and 17/29-2020 TGT Pro(2) dated 14.01.2025 are hereby withdrawn/modified to the extent that the actual benefit has been denied to the petitioner from the date of promotion. It is hereby directed to grant the benefits of actual payment to the petitioner for the period from 22.03.2016 to 23.07.2020 and release all consequential benefits including arrear for the above said period accordingly under intimation to this office positively.

Note:-The matter regarding payment of interest of 6% is being taken up separately, with the Finance Department approval.

Terms & conditions:-

1. The release of benefits shall be subject to the final outcome of any SLP/ Appeal, filed by the Department in this regard.
2. This is a special case and the same shall not be considered as precedent in any other case in future.
3. Recovery shall be made from the defaulting officers/officials of the above said arrear as per due administrative procedures.

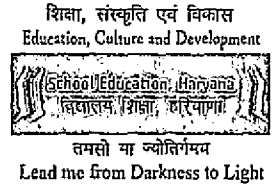
