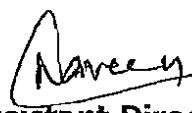

The Permission/NOC to go abroad is hereby granted to **Smt. Swati Arya (204711), JBT, GMSPS DLF Phase – 1, Distt. Gurugram** from **03.10.2026 to 30.03.2027 (179 days)** on following terms and conditions:-

7. He/She will not be inviting any liability during his/her stay at abroad which may result into losses to Govt. in any matter.
8. If any, criminal case/Departmental Proceeding (s) is filed against teacher from the date of issue of present permission to go abroad till the date of departure, then the permission to go abroad will be stand cancelled automatically.
