Subject: Cancellation of appointment as Steno Typist in J&K Legal Services Authority – appointment thereof.

Whereas, J&K Legal Services Authority appointed 20 Steno Typists vide Order No. 234-SLSA(Estt) of 2021 dated. 12.11.2021.

Whereas, during the verification of documents of the selected candidates, it was found that one candidate namely Aditya Kumar S/O Ashok Kumar R/O Mast Garh, Jammu selected under Schedule Caste (SC) category does not belongs to the Schedule Caste category. Infact, said Aditya Kumar belongs to Social Caste Category as per the certificate produced by him. In the category of Social Caste, Ms. Sapna Bamotra has been selected, whose merit is above the merit of Aditya Kumar. So, Sh. Aditya Kumar falls short of merit to be selected in the category of social caste also.

Consequently, the appointment of Shri. Aditya Kumar R/O Mast Garh Jammu selected under Schedule Caste Category as Steno Typist in J&K Legal Services Authority ordered vide order no . 234- SLSA(Estt) of 2021 dated 12.11.2021 is hereby cancelled.

Sequel to above, sanction is accorded to the appointment of Smt. Shivali Bogia D/O Tarsem Kumar R/O Channi Himmat, Jammu falling next in the merit list as Steno Typist under (SC) category in J&K Legal Services Authority in Level-5 (Rs. 29,200 - 92,300).

The above appointee shall report to the Member Secretary, J&K Legal Services Authority Jammu within a period of 15 days from the date of issue of this order. In case of faiulure to join within the stipulated period, her appointment shall be deemed to have been cancelled without any further notice.

The other terms and condiditions of appointment shall remain same as laid down in the Order No. 234- SLSA(Estt) of 2021 dated 12.11.2021.
