**Temple Thiruppani (Renovation and Conservation)
Works Module implemented in
Integrated Temple Management System (ITMS)**

Thiruppani work includes construction, conservation, restoration and renovation of Temples and Buildings under the administration of the Hindu Religious and Charitable Endowments (HRCE) Department, Government of Tamil Nadu.

NIC Tamil Nadu has developed an exclusive module named “**Thiruppani**” as part of the Integrated Temple Management System (ITMS). This module is a workflow-based approval system of Thiruppani works proposed by the temples.

Thiruppani module has the following features:

-  **Thiruppani Entry at Temple Level:** The temple will enter the Thiruppani work information and upload the required documents. The project proposal will be generated by the system with a unique proposal ID and forwarded to JC, Regional Office.
-  **Selection of Experts by JC Regional Level:** The Joint Commissioner at Regional Office will select the experts and the project proposal will be forwarded to the expert's login along with SMS and e-mail notifications for needful.
-  **Expert Opinion at Regional Level:** The experts will submit the opinion report through the respective login and submit it to Executive Officer.
-  **Final Proposal at Temple Level:** Based on the expert's opinion, the temple prepares and submits the final project proposal along with work information to the JC Regional Office for recommendation by the Regional Level Executive Committee (RLEC).
-  **RLEC Meeting at JC Regional Level:** The RLEC Meeting will be scheduled by the JC Regional office for the Thiruppani project proposals submitted by the temples. The system notifies the meeting schedule to the temple's executive officer and RLEC members via SMS and email. The RLEC committee scrutinizes the work proposals and forwards them to JC Thiruppani at the State level.
-  **SLEC Meeting at State Level:** The JC Thiruppani will schedule the SLEC meeting for the work proposal recommended by RLEC. The SLEC

committee reviews the project proposal submitted by the temple. The committee will give recommendations like approve / approve with modifications / reject / request resubmission / recommend a site visit / refer for a departmental decision. Based on the recommendation, the project proposal will be forwarded to Estimation Section for getting the approval of Administrative Sanction, Technical Sanction.

Work Monitoring System at State Level: Further, Temple will execute the approved works through Tender Process and issue the work order. Department monitors the Physical and Financial Progress of each work at State level.

Dashboard and MIS Reports are provided for different levels of users.

As on 11th March 2025, through this system 3520 work proposals were submitted by the temples, out of which 1846 proposals are approved by the State Level Executive Committee.
