In exercise of the power vested under section 10 of the Compensatory Afforestation Fund Act, 2016 (No. 38 of 2016) and all the other powers enabling him so to do, the Governor of Haryana is pleased to constitute "State Compensatory Afforestation Fund Management and Planning Authority" (State Authority) for the State of Haryana in terms of the following:

1. The State Authority shall consist of a Governing Body and shall be assisted by a Steering Committee and an Executive Committee consisting of the following:

2. The Governing Body of the State Authority shall exercise all the powers and discharge all the responsibilities enjoined to it by and under the Compensatory Afforestation Fund Act, 2016 (No. 38 of 2016) and shall, in such performances, be assisted by the Steering Committee and the Executive Committee.

3. The terms and conditions, including the tenure, of non-official members of the Executive Committee of the State Authority shall be such as determined by the Government of Haryana.

4. The State Authority and all its constituent bodies shall exercise all such powers and discharge all such responsibilities as are enjoined to them by and under the Compensatory Afforestation Fund Act, 2016 (No. 38 of 2016).


