







1. The general approval of Stage I has been granted after the cut off date of 31-12-2019.

As per Compensatory Afforestation, 2019 guidelines of MoEF&CC, GOI, Chapter 2 Para 2.4 (i) the land proposed for CA plantation shall be transferred and mutated in the name of State Forest Department and shall be notified as Reserve Forest/Protected Forest under the Indian Forest Act, 1927 prior to Stage-II approval. No such condition was mentioned in the Stage-I approval issued in this case.
5. FRA certificate is not available.
6. Physical file was not provided by the FCA branch for scrutiny.
