Proceeding of 8th meeting of the Executive Committee of the State Compensatory Afforestation Fund Management and Planning Authority, (State Authority) held at Committee Room, Van Bhavan, Panchkula on 16.01.2023 under the Chairmanship of Sh. Jagdish Chander, IFS, Principal Chief Conservator of Forest (HoFF), Haryana.

The 8th meeting of the Executive Committee of State Compensatory Afforestation Fund Management and Planning Authority, (State Authority), Haryana chaired by Sh. Jagdish Chander, IFS PCCF (HoFF), Haryana was held on 16.01.2023. The list of the participants who attended the meeting is attached as Annexure-I.

At the outset, Dr. Vivek Saxena, IFS, Chief Executive Officer, CAMPA, State Authority, Haryana welcomed the Chairman and the members of the Executive Committee.

The Chief Executive Officer gave a brief account of the institutional mechanism of utilizing funds collected under Forest (Conservation) Act, 1980 with the formation of National and State CAMPA Authority under the provisions of Compensatory Afforestation Fund Act, 2016 and Compensatory Afforestation Fund Rule, 2018.

CEO, CAMPA also apprised that APOs for 2023-24 have been formulated by respective divisions after detailed selection of sites during last three months and proposed APO is being submitted after presentations/interactions with all the DFOs and Circle CF/CCF/APCCF. Proposed APO also comprises of KML files, GPS coordinates and photographs of the sites.

Chair of the Executive Committee Sh. Jagdish Chander, IFS, PCCF (HoFF), Haryana in his initial opening remarks conveyed the decision that for 2023-24, only mandatory Compensatory Afforestation activities and maintenance of plantations under CA &NPV will be undertaken, keeping in view the targets allocated under Green India Mission as per the briefing and information provided by APCCF, Forestry Sh. Suresh Dalal, IFS. Sh. Suresh Dalal, IFS also emphasized that NPV amount need not be used for plantation activities as Green India Mission has sufficient budgetary provisions as well as targets for the coming years.

- (c) Agenda No. 3: Annual Plan of Operations for the year 2022-23 The committee took note of approval of APO 2022-23 at a total cost of Rs. 270.68 crores in its 18<sup>th</sup> meeting held on 20<sup>th</sup> July, 2022. The Member Secretary apprised the committee that during the discussion on proposed APO 2022-23 in the 4<sup>th</sup> meeting of Steering Committee held on , Sh. Ashok Khemka, ACS S&T had submitted a Note on his observations on various proposals of APO 2022-23 and reply to these observations have been submitted during the 5<sup>th</sup> meeting of SC held on .
- (d) Agenda No. 4: Deferment of certain activities under APO 2021-22 to the first quarter of next financial year The Committee took note on the fact that an amount of Rs. 121.50 lakhs has been utilized upto 30<sup>th</sup> November against the approved expenditure of Rs. 477.02 lakhs towards completion of certain deferred activities of APO 2021-22 and observed that efforts should be made to complete the deferred activities and utilize the approved amount.

### Agenda No. 8.3: Review of Physical and Financial Progress of APO 2022-23

The Committee reviewed and noted the Physical and Financial Progress against APO 2022-23. The committee also desired that efforts should be made to achieve the physical targets under CA completely. CEO, CAMPA also emphasized that CA sites proposed by the DFOs should be reserved for undertaking CA plantations only and should not be planted under any other chief Executive Chief Exe

### Agenda No. 8.4: Proposed Annual Plan of Operations for the year 2023-24

The committee was apprised about the compiled Annual Plan of Operations 2023-24 submitted by respective divisions with total estimated outlay of Rs. 42934.96 lakhs. Keeping in view, the decision conveyed by Executive Committee chair in opening remarks, only mandatory plantation activities under CA and maintenance of earlier plantations under NPV etc. were deliberated and total outlay of APO 2023-24 would become Rs. 17821.61 lakhs.

Agenda No. 8.4.1: Proposals under site specific activities of new plantations under Compensatory Afforestation and maintenance of CA plantations.

The committee was apprised about the progress of CA plantations which is summarize below:-

CEO, CAMPA also apprised that most of the divisions submit request for change of CA sites, non-availability of land for plantation as per approved APO by National Authority.

An amount of Rs. 8720.19 lakhs is proposed to be incurred for new plantations and an amount of Rs. 4564.80 Lakhs is proposed to be incurred on Maintenance of plantations under CA as per the approved CA schemes. The Committee considered and recommended an amount of Rs 13284.99 Lakhs for new plantations and maintenance as per approved CA schemes under Compensatory Afforestation.

#### 8.4.2.3 Silvi-cultural operations in forests: Rule 5(2)(c)

The Executive Committee did not recommend the proposal under this Rule.

#### 8.4.2.4 Protection of plantations and forests: Rule 5(2)(d)

The total cost proposed for carrying out the operations under this proposal is Rs. 658.00 lakes. The Executive Committee did not approve the proposal under this Rule.

#### 8.4.2.5 Pest & Disease control in forests: Rule 5(2)(e)

Ambala Forest Division has proposed an expenditure of Rs. 0.50 lakhs towards purchase of pesticides/insecticides for effective pest and disease control measures. The Executive Committee did not approve the proposal.

#### 8.4.2.6 Forest Fire prevention and control operations: Rule 5(2)(f)

The Executive Committee discussed various proposals under this rule at a total cost of Rs 222.28 Lakhs and did not approve the proposal.

#### 8.4.2.7 Soil and Moisture Conservation: Rule 5(2)(g)

The Committee was presented the submitted proposals of Rs. 8515.67 lakhs. Keeping in view, the decision of Chairperson Executive Committee i.e. PCCF (HoFF), Haryana, the proposal was not discussed and not recommended.

Chairperson Executive Committee i.e. PCCF (HoFF), Haryana subsequently while Executive Office!

Ana, Panging."

"SMC works in Shiwalik region to the extent of not more than 20 crores (Ten crores each in Morni & Yamuna Nagar Divisions".

CEO, CAMPA, State Authority, Haryana on the above observations is of the view that the site wise proposal in respect of SMC works as desired by PCCF (HoFF), Haryana need to be considered by the Executive Committee after receipt of site wise proper justification along with KML files and GPS coordinates through respective Circle CF/CCF/APCCF and forwarding of the same by PCCF (HoFF), Haryana. Keeping in view the surrendering of SMC targets and budget by the Circle CCFs at a later stage without any proper justification leads to piquant situation wherein the allocation of physical and financial targets were made as per the approval and recommendation of Executive Committee, Steering Committee and National Authority.

## 8.4.2.8 Improvement of wildlife habitat as provided in the approved wildlife management plan or working plan: Rule 5(2)(i)

Wildlife Divisions have proposed various activities for management and improvement of Wildlife habitat at a total cost of Rs. 2115.46 lakhs. These proposals also include various activities for supporting and strengthening the infrastructure related to Wildlife Management. The Divisions have been directed to certify about inclusion of the proposed activities in the respective approved Wildlife Management Plan or Working Plan.

The Executive Committee considered the proposal and recommended an amount of Rs. 500.00 lakes subject to the condition that activities are to be undertaken as per approved Wildlife Management Plan or Working Plan only.

# 8.4.2.9 Supply of wood-saving cooking appliances and other forest produce saving devices in forest fringe villages as specified by the National Authority from time to time: Rule 5(2)(1)

Ambala Forest Division has proposed distribution of Solar cookers in various villages at a total cost of Rs. 103.50 lakhs. These forest produce saving devices will be distributed mainly in those villages where dependence of local population on fire wood is significant. Chairperson desired that APCCF, North Circle, Ambala Sh. S. Narayanan, IFS who is also having charge of DG, Hareda to explore and submit the proposals in respect of above component for the entire Haryana State.

### 8.4.2.10 Management of biological diversity and biological resource. Rule 5(2)(m)

Jind Forest Division has proposed establishment of bio-diversity park over an area of 9 thief Executive Officer protected forest which is located at Qila Zafargarh, a historic fort in village Zafargarh on Campa (State CAMPA (State of protected forest which is located at Qila Zafargarh, a historic fort in village Zafargarh on Rohtak-Jind Highway. The total cost proposed for the project is Rs. 200 lakhs. Similarly, Faridabad Forest Division has proposed a study on assessment of bio diversity in Manger Bani forests at a total cost of Rs. 5 lakhs.

The Chairperson Executive Committee, i.e. PCCF (HoFF),, Haryana while approving the Minutes has not approved the proposal related to Biodiversity Park at Qila Zafargarh and has made following observations:-

"Please drop proposal under management of biodiversity and bio-resource as there is no write up to justify the inclusion of renovation of Qila Zafargarh in Jind district."

Keeping in view, the decision of Chairperson Executive Committee i.e. PCCF (HoFF), Haryana, the proposal was not discussed and not recommended.

# 8.4.2.14 Construction of residential and official buildings in forests for front line staffs deployed for protection of forest and wildlife: Rule 5(3)(e)

Various forest divisions have proposed construction of residential and office buildings for the frontline staff, the details of which will be given in APO Booklet. The total cost of the proposals under this Rule is Rs. 668.16 lakhs.

Keeping in view, the decision of Chairperson Executive Committee i.e. PCCF (HoFF), Haryana, the proposal was not discussed and not recommended.

# 8.4.2.15 Publicity-cum-awareness program and exhibition on the various schemes being implemented by the State Authority from State Fund: Rule 5(3)(i)

Keeping in view, the decision of Chairperson Executive Committee i.e. PCCF (HoFF), Haryana, the proposal was not discussed and not recommended.

# 8.4.2.16 Survey and mapping of forest areas for forest fire control, compensatory afforestation works, soil and moisture conservation, catchment area treatment and wildlife management for preparing annual plans to be executed from the State Fund: Rule 5(3)(g)

It is proposed to carry out demarcation of strip forest along roads and canals to consolidate their boundaries and include them in the Annual Plans for prospective plantations. Various divisions have submitted proposals for this activity at a total cost of Rs. 127.25 lakhs.

Keeping in view, the decision of Chairperson Executive Committee i.e. PCCF (HoFF), Haryana, the proposal was not discussed and not recommended.

# 8.4.2.17 Independent concurrent monitoring and evaluation and third-party monitoring Of various works: Rule 5(3)(h)

The State Authority has identified the third-party agencies for carrying out monitoring and evaluation of works under CAMPA in the year 2021-22. Similarly, the Authority proposes to carry out independent M&E of its activities carried out during the year 2022-23. The tentative cost for Chief Executive Officer would be Rs. 75.00 lakhs.

The cost norms proposed for new plantations and maintenance under CA are those which are based on the CA schemes which were approved earlier. Since there is significant increase in the wage rate, a provision for incremental cost on account of enhanced wage rate is to be made for new plantations and maintenance of plantations under CA. It is proposed that an amount of Rs. 1000.00 lakhs will be earmarked for this purpose.
