

Internal Auditors' Report on the accounts of The State Compensatory Afforestation Fund Management & Planning Authority (State Authority), Haryana, Van Bhawan, Sector-6, Panchkula for the year ended 31st March 2021

We have audited the accompanying financial statements of State CAMPA (State Authority), which comprises the Balance Sheet, Income and Expenditure Account, Receipt and Payment Account as at 31stMarch 2021 and summary of significant accounting policies and other explanatory information. The significant parts of the financial statements are as under:-

Reserves and Surplus:

- The unspent interest income has been shown as liability under the head Reserve and Surplus as this unspent amount at the year end is to be spent in the next accounting year.
- 2) An amount of Rs 2,94,99,367/- was earned as interest on funds kept in Saving Bank Accounts (SB) and in Saving Bank Sweep account. Out of this a sum of Rs 96,16,302/- (including Rs. 2,13,318/- on capital expenditure) were spent on Establishment, Administrative Expenses and on Monitoring and Evaluation. Thus leaving an unspent amount Rs 1,98,83,058/-. The previous year's unspent amount was Rs. 13,31,29,640/- Thus, the cumulated unspent balance on this account comes to Rs. 15,30,12,698/-

Earmarked/Endowment Funds:

- 1) The unspent grant has been shown as liability under the above head, since; this unspent grant at the year end is to be spent in the next accounting year.
- 2) An amount of Rs 1,92,88,90,000/- was authorized by the National Authority CAMPA during the year. An amount was drawn from the Government Account and transferred to State CAMPA. The balance on 31-03-2020 was Rs. 16,92,39,159/- and total funds available were Rs. 2,09,81,29,159/-. A sum of Rs. 1,24,34,78,737/- (including Rs. 9,77,00,251/-. on capital expenditure) was spent on different activities. As such total accumulated balance comes to Rs 85,46,49,942/-.

Contingent liabilities:

- 1) Neither there are any court cases filed by the Authority nor any court cases against the authority. Therefore, there are no contingent liabilities.
- 2) There are no other liabilities against the Authority.
- 3) No advances given to the staff during the year 2020-21. There were no liabilities.

Assets:

- 1) The Bank balances have been shown separately for Scheduled Banks and Nonscheduled Banks.
- 2) The Cheque being cash for all purpose in term of financial rules, have been reduced from the bank balance. The net bank balances have been taken in the accounts.
- 3) There were no transactions against sundry debtors.

Interest Income:

The interest income has been received from Scheduled Bank and the interest from Nonscheduled Banks was not substantial.

Other Income:

Balance of Rs. 13,59,724/ accumulated on 31.03.2020. Further, a sum of Rs. 38,00,236/on account of miscellaneous receipts was received during the year. Thus total Rs. 51,59,960/has accumulated as at the end of 31.03.2021.

Felling Charges:

Felling Charges of Rs. 16,00,940 were received during 2020-21 from User Agencies. Rs. 2,23,68,151/- were standing on 31-03-2020 and accumulated balance against this account was Rs. 2,39,69,091.

Other Legal and regulatory requirements:

- 1) The authority has generally maintained proper records.
- 2) The Balance Sheet, Income and Expenditure Account and Receipt and Payment Account are in agreement with the books of account.
 - i. The authority has no long term contracts.
 - ii. The physical verification of assets has been conducted during the year as per the practice followed in the Haryana Forest Department and no discrepancies are noticed.
- iii. The Accounts have been prepared on the basis of Cash Account system.

Notes to the Financial Statements of State Compensatory Afforestation Fund Management & Planning Authority (State Authority), Haryana, Van Bhawan, Sector-6, Panchkula for the year ended 31st March 2021#

i. Overview of Nature of Business/Operation:

The Haryana State Compensatory Afforestation Fund Management & Planning Authority (State Authority) is intended as an instrument to accelerate activities for Compensatory Afforestation, Forest Resource Management, Prevention of Natural Forests, Management of Wildlife and Infrastructure Development in the sector and allied works. It has to provide an integrated framework for utilizing multiple sources of funding and activities relating to Protection and Management of Forests and Wildlife. Its prime task is to regenerate natural forests, strengthen and build up the institution engaged in this work.

2. Significant Accounting Policies:

i. Accounting Conventions and Basis of Preparation of Financial Statements:

The financial statements are prepared in accordance with generally accepted accounting principles in India, on cash payment basis.

ii. Investments:

Investments are carried at cost.

iii. Fixed Assets:

Fixed Assets are stated at cost of acquisition inclusive of inward freight, duties and taxes and incidental and direct expenses related to acquisition. In respect of projects involving construction, related pre-operational expenses (including interest on loans for specific project up to its completion) form part of the value of the assets capitalized.

iv. Capital Work in Progress:

Expenditure on capital work in progress (assets under construction) shall be accounted for under respective fixed assets on completion/construction of the asset.

v. Depreciation:

Depreciation is provided on historical cost/ W.D.V. (written down value) method as per rates specified in Income Tax Act 1961.

In respect of additions to/ deductions from fixed assets during the year, depreciation has been provided for full year for addition made upto 30^{th} September and for the half year for addition after 30^{th} September.

vi. Funds received from Central CAMPA, New Delhi/Government Grants/Subsidies:

Funds received from National CAMPA, New Delhi are accounted on receipts basis. Funds are received under various heads like Compensatory Afforestation (CA), Catchment Area Treatment Plan (CAT Plans) and unspent amount of grants at the end of the year are carried forward and classified under Corpus/Capital Funds to be utilized in next accounting year.

vii. Contingent liabilities:

There are no identified contingent liabilities.

viii. Current Assets, Loans and Advances:

In the opinion of the management, the current assets, loans and advances have a value on realization in the ordinary course of business, equals at least to the aggregate amount shown in the balance sheet.

ix. Income Tax:

The Organization is non-profit making entity; therefore, no provision for income tax is required.

x. Retirement Benefits:

The employees working for State CAMPA (State Authority) are the permanent employees of the Forest Department of Haryana and other employees of State CAMPA have been engaged on Outsource basis. Therefore, no provision for retirement benefits of employees is made.

xi. Utilization of Interest Income:

The expenditure on the establishment, administrative expenditures and expenditure on Monitoring & Evaluation are met out of interest income earned on the funds invested in the Bank Deposits as per Rule 6 of Compensatory Afforestation Fund Rules, 2018.

xii. Related Party Disclosure:

No transactions are made with the related parties.
