


**Proceedings of the 9<sup>th</sup> Meeting of the Executive Committee of State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) held on 02.11.2023 at 1430 Hrs under the Chairmanship of Shri Jagdish Chander, IFS, Principal Chief Conservator of Forests cum HoFF, Forest Department, Haryana.**

The list of participants is at Annexure-I.

2. CEO, CAMPA cum Member Secretary of the Committee briefly explained the agenda items for the 9<sup>th</sup> Executive Committee (EC) Meeting and took up the same one after another.
3. **Confirmation of Minutes:** Minutes of the 8<sup>th</sup> meeting of EC were confirmed.
4. **Committed Liabilities:** CEO, CAMPA explained the approvals granted by National CAMPA on the proposed APO sent by the State CAMPA and informed that out of the total proposed outlay of Rs.252.66 Cr, the National Authority had approved only Rs.49.93 Cr, that too, with specific conditions and subject to submission of additional information/reports. Thereafter, Additional PCCF (Forestry) briefly presented the Committee on the committed financial liabilities of the Department, which have been carried out being seasonal and unavoidable activities, in anticipation of the approval of National CAMPA. The committed expenditure in these sites may be forwarded to National CAMPA with the request to release the funds for meeting out the expenses on the executed works. Similarly, the expenditure incurred on maintenance of previous plantations and ANR plantations, which have been approved, subject to submission of the reports on sites and survival, has to be demanded from the National Authority. The State CAMPA has already compiled the requisite information as requested by the National CAMPA. The issue was discussed at length by the EC and the same was approved by the Committee.
5. **Approved Allocations:** CEO CAMPA presented the component wise allocation by National CAMPA in detail and the Committee noted the same.
6. Chairman informed that there has been a delay in convening the meeting of EC and the same be convened every quarter, as mandated in the Act.














