**Subject: Group Personal Accidental Insurance under Mukhyamantri Haryana Karamchari Durghatna Bima Yojana.**

*Respected Sir,*

It is well aware that the State Government has constituted Haryana Parivar Suraksha Nyas, a Trust registered under the Finance Department with the main objective to implement and rationalize the schemes related with compensation for death/accident/property loss and to support the victim and/or dependent with timely support.

Now, the Trust has signed MoU with the IFFCO-TOKIO General Insurance Company w.e.f. 20th May, 2022 for one year to provide the Group Personal Accidental Death Insurance Cover of Rs. 5 lakh per employee to Safai Karamchari (both Contractual & Regular) of Urban Local Bodies department and Development & Panchayat department and Insurance cover of Rs. 10 lakh to Group 'C' & 'D' category of employees namely Firemen & Fire Drivers of Urban local Bodies, Linemen & Assistant Linemen of Power Department, sewer men of Public Health & Engineering Department associated with Government of Haryana involved in high risk category.

As per the agreed MoU, any claim arising must be notified by the respective department/Organisation to the Insurer within 30 days of the death of the employee in the prescribed claim form alongwith the PPP ID of the employee.

I would also request you to please aware/ sensitize the field offices under your control so that any untoward incident can be reported timely for settling the claim of the deceased employee. A copy of the agreed MoU, Policy Document & Claim form are attached herewith for your reference please.
