Quotations for providing accidental insurance to Group "C" & "D" category of employees working under high risk category of jobs while on duty and to the Safai Karamcharis working in Urban and Rural areas under Mukhya Mantri Haryana Karamchari Durghatna Bima Yojna (MMHKBY).

I am directed to kindly refer to the subject cited above.

This is to inform you that the State Government has constituted a new Trust namely "Haryana Parivar Suraksha Nyas" with the main objective to compensate for the death and accident and to support the victim and/or dependent with timely support.

The State Government intends to provide insurance cover to the following category of its employees:-

A. Group "C" & "D"

- a. Group C & D (contractual employees) working in high risk job like Fireman, Fire driver, Lineman, Assistant Lineman, Sewer man. It is estimated that the number of such employees working on contractual basis would be approximately 11,000.
- b. An accidental insurance cover of Rs. 10.00 lakh per employee is proposed to be provided for covering accidental death/ disability of these employees while on duty.

B. Safai Karamcharis working a urban and Rural areas

- a. Safai Karamcharis (both Contractual & Regular) of Urban Local Bodies Department and Development & Panchayat Department in case of accidental death. It is estimated that the number of Safai Karamcharis working in this category would be approx. 33000.



- b. An accidental insurance cover of Rs. 5.00 lakh per employee is proposed to be provided for covering accidental death/disability of these employees while on duty.

The Trust will pay premium along with the number of members to be covered (as unnamed policy) under both the categories. You are, therefore, requested to kindly provide sealed quotations for the premium to be charged per lakh per employee to such category as mentioned above. **Sealed quotations with subject marked should be sent to the office of Haryana Parivar Suraksha Nyas (HPSN), Panchkula latest by 15th May, 2023 by 5:00 P.M.** The quotes will be opened on same day at 5.30 PM in front of the representatives of the insurance companies and the representatives of insurance companies are requested to attend the same.
