**Subject : Conduct and behavior of a Judicial Officer.**

Madam / Sir,

In continuation of the earlier circular letters on the above subject, I have been directed by the Hon'ble Court to inform that in view of certain instances



of insubordination which have come to the notice of the Hon'ble Court, following directions have been issued for being communicated to all the Judicial Officers.

1. The conduct, behavior and integrity of the Judicial Officer should be unquestionable.
2. District Judges should exercise strict supervision over the Subordinate Judicial Officers.
3. It should always be kept in mind by all the Judicial Officers that District Judge is the Chief Judge and head of judiciary in the district. Officers subordinate to the District Judge should respect and should abide by all the directions issued by District Judge. There cannot be any scope of insubordination or indiscipline by the Judicial Officers.

You are, therefore, requested to kindly bring these directions to all the Judicial Officers for information and strict compliance.
