

DAILY LOK ADALAT IS CONDUCTED IN THE PREMISES OF HON'BLE HIGH COURT OF UTTARAKHAND

A Daily Lok Adalat has been organized from 01.05.2024 by the Hon'ble High Court of Uttarakhand at ADR Center, Nainital, in which Hon'ble Mr. Justice J.C.S. Rawat (Retd.) is initially nominated to deal with the matters in Lok Adalat. Later on, the Registrars of the Court are also nominated to deal with the matters in Lok Adalat on alternative days. The main purpose to start the Daily Lok Adalat is to settle the dispute amicably and to reduce the pendency of the Hon'ble High Court.

MAJOR ACTIVITIES OF STATE LEGAL SERVICES AUTHORITY FROM

APRIL 2024 TO JUNE 2024

➤ OBSERVATION OF "INTERNATIONAL WORKERS DAY"

'International Workers Day (May Day) was observed on 01.05.2024 by all the Districts Legal Services Authorities in cooperation with TLSCs, Panel Lawyers, PLVs and Labours' Community and Legal Awareness/Services Camps were organized throughout the State. The attendees were sensitized about NALSA (Legal Services to the workers in unorganized sector) Scheme, 2015 extending benefits of the Welfare Schemes for unorganized workers, processing and furnishing application form for registration to avail benefits under various Govt. Schemes and also to make aware about statutory duties of employers, Labour Laws, minimum wages Act etc.

> CAPACITY BUILDING/TRAINING PROGRAMMES

During May, 2024 Training-cum-Sensitization Session titled as "Awareness Camp/Workshop was organized on the Provisions of Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (in Short POSH Act)". The participants were imparted training relating to the provisions of POSH Act, NALSA Schemes, Legal Aid Services provided by the SALSA, DLSA, TLSC, Rules & Provisions of JJ Act, JJ Rules, D.V. Act, Women Rights, Child Rights. The event was attended by 226 participants (approx) including Panel Lawyers, PLVs, etc. from various DLSAs.

➤ CELEBRATION OF "WORLD ENVIRONMENT DAY" ON 05th JUNE, 2024 AS CLEANLINESS DRIVE FOLLOWED BY SHRAMDAAN

As we know that every year "WORLD ENVIRONMENT DAY" is celebrated on 05th June. The World Environment Day is a special occasion to come together and

appreciate the natural beauty of our planet. The day is to reflect on how we can protect and preserve the environment for future generations and to create a positive impact on our world.

The key issue of environment protection and preservation is pollution such as plastic pollution, air pollution and food security and all about fighting against plastic pollution, one of the biggest challenges we are facing today, from oceans filled with plastic bottles to forests littered with plastic bags, our environment needs our help more than ever.

Keeping in view the importance and necessity of our environment pollution free and clean, the Hon'ble Executive Chairman, Uttarakhand SLSA, Nainital directed all DLSAs to observe and celebrate "World Environment Day" as "Cleanliness Drive" followed by "ShramDaan" on 05th June, 2024 across the State of Uttarakhand.

Accordingly, all District Legal Services Authorities have been directed:-

- To observe and celebrate "World Environment Day" on 05th June, 2024 across the State, especially in rural and remote areas by including Tehsil Legal Services Committees, Panel Lawyers and Para-Legal Volunteers (PLVs).
- 2. During the programme:
- a) Awareness programmes and camps are to be organized in Schools and Colleges; in Factories and Industrial areas; at Panchayat and Village levels; far-flung rural areas of the district.
- b) Aware the people at large about Environment Protection Act; Plastic Waste Management Rules, 2016; Uttarakhand Plastic & Non-biodegradable Garbage Act, 2013; Solid Waste Management etc.
- c) A "Cleanliness Drive" followed by "SharmDaan" shall be conducted in the entire District on 05th June, 2024.
- d) Awareness Rallies;
- e) Radio Talk show or Nukkad Natak
- f) Drawing/Slogan/Essay Competition
- g) Wider and Adequate publicity of this campaign
- h) To upload News, Information, Photographs and Videos of the activities in the social medial platforms.

- A "Cleanliness Drive" followed by "SharmDaan" shall be conducted in the entire District on 05th June, 2024.
- 4. Effective coordination and active participation of all stakeholders.

To make the aforesaid awareness campaign a grand success and in order to ensure the compliance of the directions issued by the Hon'ble Executive Chairman, UKSLSA, the aforesaid Awareness Campaign was successfully organized by the District Legal Services Authorities in their districts in association with the concerned stakeholders.

On the basis of the statistical information furnished by the District Legal Services Authorities relating to the said campaign, a consolidated report has been prepared as under:-

Cleanliness Drive was organized at Riverside areas

It is kindly submitted that as per the District-wise reports in the tabular form mentioned above, it is found that during the aforesaid Awareness 'World Environment Day' celebration/campaign, total 670 awareness programmes including camps were organized (243 in Schools & Colleges, 408 Panchayat/Village Level and Far-Flung Rural Areas and 19 in Factories/ Industrial Areas) and around 26379 persons have attended these awareness programmes/camps (14192 Students, Teaching & Non-teaching staff in Schools & Colleges, 11725 common mass and villagers including senior citizens, women, children etc. living in Villages and Far-Flung Rural Areas and 462 unorganized labourers working in the Factories/ Industrial Areas).

Also, informed that total 99 Awareness Rallies, 21 Nukkad Nataks, 152 Drawing/Essay/Slogan Competitions were organized. During the course of awareness campaign, public including students, youth generation, senior citizens, women and children were sensitized in length about Water Conservation, Solid Waste Management, Effect of Global Warming, Tree Conservation, Ill effects of Sand Erosion, Ill effects of Soil Desertification, Plastic Waste Management Rules 2016, Prevention and ill effects of pollution, Uttarakhand Plastic and Non-biodegradable

Garbage Act 2013, Article 51A, Environment Protection Act, Uttarakhand Govt. Notification No. 84/XXXViii-1-20-13(11)/2021, dated 16.02.2021.

It is kindly submitted that during the celebration of 'World Environment Day' as Cleanliness Drive followed by "ShramDaan" on 05.06.2024, valuable coordination was received by the District Administration, Police, Village Heads/Pradhans, School and College Administration and other concerned stakeholders.

In order to make this campaign a grand success, all the District Legal Services Authorities made wider publicity of the aforesaid World Environment Day campaign as cleanliness drive followed by ShramDaan through different Digital Platform. Information and news were also being uploaded on the Facebook Page of the DLSAs.

OBSERVATION OF "INTERNATIONAL YOGA DAY":

On the event of 'International Yoga Day' on 21.06.2024 all the District Legal Services Authorities have organized Yoga Sessions within their districts, across the State of Uttarakhand. The PLVs and other stakeholders also conducted Yoga Sessions at their deputed areas. During the Yoga Sessions participants were informed that doing Yoga is a transformative practice, represents the harmony of mind and body. Further, during the yoga session the importance of slogan "Yoga for Me and for Society," has been explained and also informed in length about its physical, mental, spiritual benefits and discipline of healthy & sustainable life by practicing yoga and other physical activities.

> OBSERVATION OF "INTERNATIONAL DAY AGAINST DRUG ABUSE AND ILLICIT TRAFFICKING":

On 26th June, 2024 all District Legal Services Authorities, Tehsil Legal Services Committees, PLVs and other stakeholders observed the "International Day Against Drug Abuse and Illicit Trafficking". Legal Awareness Camps including the campaign aimed at raising awareness about the Drug Abuse and Illicit Trafficking were organized

and the participants were asked to achieve the goal of drug free society. People at large were also informed that the issue of drug abuse poses a complex challenge affecting people at large in the State. The participants were also informed about ill effects of drugs, prevention, treatment and also that the impact of drugs is far-reaching and complex.

> AWARENESS PROGRAMME FOR JUDICIAL OFFICERS:

As per Action Plan for June, 2024, special awareness programmes were organized by the District Legal Services Authorities in the districts for Judicial Officers in the State of Uttarakhand on the topic "The Uttarakhand Compensation Scheme for Women Victims/Survivors of Sexual Assault/Other Crimes, 2020".

In the said awareness programmes, the participants were informed in length about aforesaid scheme, keeping in view the NALSA Scheme Compensation Scheme for Women Victims/Survivors of Sexual Assault/other Crimes - 2018. Further informed that the SLSA or DLSA may award compensation to the victim or her dependents to the extent as specified in the scheduled attached hereto.

> PREVENTION OF SALES OF EXPIRY ITEMS:

As per directions of the Hon'ble Executive Chairman, UKSLSA, Nainital, monthly meetings are being convened by the Secretaries of District Legal Services Authorities (DLSAs) across the State of Uttarakhand with Food Safety Officer and Drug Inspector of the concerned district with regard to prevention of sales of expiry items/packets/packed foods, drinks. Raid/Inspections are also being done to the malls, shops, markets, medical stores, general stores etc.

The committee constituted for the purpose has been directed to conduct all needful exercise as per law, if any such matter found in the district.

During the period the District Legal Services Authorities convened 28 Meetings with Food Safety Officer and Drug Inspector and Anti-Drug Team Members, 128 surprise inspections/visits to shops, stores, medical stores, malls by the concerned officers, about 227 samples collected from the shops, malls and stores and were sent to laboratory. The concerned officers also informed that show cause notices were issued to different firms as per Medicine Act, 1940 and Rules 1945.

> ACTIVITIES AND PROGRAMMES ORGANIZED FOR PRISONERS:

During the period April-2024 to June-2024, total 155 Legal Services & Awareness Camps were organized by the District Legal Services Authorities along with Chief Legal Aid Counsel, Retainer Lawyers, Panel Lawyers, PLVs. Total 226 Visits/Inspections were also conducted and during the visit interaction sessions were also organized with inmates to know the progress of their cases and about legal aid relating issues. In the legal awareness camps under trial prisoners were informed about early access to Justice at Prearrest, Arrest and at Remand Stage, Compounding of Offences, Rights of Remission, and Commutation etc. Further, directions were given to ensure that the applications of the prisoners seeking free legal aid are immediately sent to the District Legal Services Authorities. During the period, total 1057 Under Trial Prisoners were provided free legal aid to defend their cases in different Courts.

> AWARENESS AND OUT REACH PROGRAMMES:

During the month April to June, 2024, total 2428 Legal Awareness Camps were organized at community level in remote far-flung areas, at market places and in urban areas by all DLSAs including TLSCs, PLVs and Panel Lawyers. These camps were attended by 116224 person across the State of Uttarakhand and they were sensitized about NALSA (Legal Services to the Workers in the Unorganized Sector) Scheme 2015, Cybercrime, Internet & Social media frauds/scams, Revenge Porn, Cyber Stalking, Cyber Harassment, Cyber bullying, Child help line 1098, NALSA helpline no.15100, Prevention and Treatment, Early Access to Justice at Pre-arrest, Arrest and Remand Stage, Child Marriage Ban, Child Labour Ban, e-initiatives as e-True Copy, e-filing, Drug Abuse, POCSO Act, D.V. Act, NALSA Portal (LSMS and LAIS) etc. The said camps were attended by approx. 89,692 people.

> OUT REACH PROGRAMME AT SCHOOLS AND COLLEGES:

Total 1311 Legal Awareness camps were organized at School and College level at District, Tehsil and Block level and the said camps were attended by Students, Teaching and Non-teaching Staff and Parents. In the said camps people at large were informed about the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, Cyber Crimes, Social Media Scams, Cyber Harassment, Revenge Porn, Cyber stalking, NALSA (Legal Services to the workers in the un-organized Sector) Scheme 2015, Labour laws, Minimum wages, POCSO Act, Good touch & Bad touch etc. These programmes were attended by about 77302 students.

➤ "15 DAYSAWARENESS CAMPAIGN FROM 01 JUNE, 2024 TO 15 JUNE, 2024 ON WOMEN RIGHTS & EMPOWERMENT AND CHILD RIGHTS & THEIR PROTECTION":

In view of Article 15(3) of the Constitution of India, special provisions for the Women and Children may be made.

Furthermore, it is kindly submitted that the Constitution of India provides equality before the law for every person and the right to life with dignity and personal liberty to all. The Constitution empowers the Government to take affirmative actions, especially for women and children, so as to enable them to enjoy the fruits of development. Several legislations for women covering different areas like health, reproductive benefits, education, right to property, employment are in place to achieve the goal of gender equality.

On the other hand, children are particularly more vulnerable to exploitation and abuse than adults. Hence, children need to be protected.

All people under the age of 18 are entitled to the standards and rights guaranteed by the various laws established as per the mandate of the Constitution of India and accordingly, there is a constant need to bandwagon on Child rights, as the child rights are the subset of human rights. Apart from this, NALSA, New Delhi has also formulated schemes namely; NALSA (Child Friendly Legal Services to Children and their Protection) Scheme, 2015 and NALSA (Victims of Trafficking and Commercial Sexual Exploitation) Scheme, 2015 in this regard.

Therefore, Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority was of the view that it would beappropriate conduct awareness programmes, camps and other similar activities for the Women and Children.

Accordingly, the Hon'ble the Executive Chairman, Uttarakhand State Legal Services Authority was pleased to direct all the DLSAs to conduct"15 Days Awareness Campaign underlining the Acts, Rules, Schemes, Provisions & NALSA Schemes specially framed for the welfare of Women and ChildProtection" in the State of Uttarakhand from 01st June, 2024 to 15thJune, 2024and to submit a consolidated report.

In order to make the aforesaid Campaign a success, following necessary directions were issued to all the District Legal Services Authorities:-

- A. All the DLSAs have been directed to organize a "15 Days Legal Awareness Campaign on Women Rights & Empowerment and Child's Rights & their Protection" in the district w.e.f. 01st June, 2024 to 15th June, 2024.
- **B.** All the DLSAs have been directed that during the aforesaid 15 days Campaign, the following activities is to be carried out by the DLSAs:-
- (i) Awareness Programmes and Camps may be organized in Schools and Colleges, wherein children shall be sensitized about the NALSA (Child Friendly Legal Services to Children and their Protection) Scheme, 2015, NALSA (Victims of Trafficking and Commercial Sexual Exploitation) Scheme, 2015 and shall also be made aware about the various laws and rights relating to Women and Children.
- (ii) Awareness Programmes and Camps shall also be organized in Panchayat Levels, Village Levels and Far-flung Rural Areas, wherein public at large shall be made aware about the NALSA (Child Friendly Legal Services to Children and their Protection)

Scheme, 2015, NALSA (Victims of Trafficking and Commercial Sexual Exploitation)
Scheme, 2015 and shall also be made aware about the various laws and rights relating to
Women and Children.

(iii) Awareness Programmes and Camps shall also be organized in Observation Home/NariNiketans/Girls Homes/Children Home/Shelter Home/Special Home, wherein gathering shall be made aware about the NALSA (Child Friendly Legal Services to Children and their Protection) Scheme, 2015, NALSA (Victims of Trafficking and Commercial Sexual Exploitation) Scheme, 2015 and shall also be made aware about the various laws and rights relating to women and children.

In order to make the aforesaid awareness campaign a grand success and in order to ensure the compliance of the directions issued by the Hon'ble Executive Chairman, Uttarakhand State Legal Services Authority, the aforesaid Awareness Campaign was successfully organized By the District Legal Services Authorities in their districtsin association with all the concerning stakeholders.

- (iv) In addition to the other laws, special focus shall also be given to the following topics during the said Campaign:-
- (a) NALSA (Child Friendly Legal Services to Children and their Protection)
 Scheme, 2015;
- (b) NALSA (Victims of Trafficking and Commercial Sexual Exploitation) Scheme, 2015
- (c) The Protection of Women from Domestic Violence Act, 2005.
- (d) Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.
- (e) Prohibition of Child Labour;
- (f) Pre-concept and Pre-natal Diagnostic Techniques
- (g) Prohibition of Child Marriage;
- (h) Prohibition of Child Trafficking.

- Juvenile Justice Act, 2015;
- (j) Right of Children to Free and Compulsory Education;
- (k) POCSO Act-2012;
- (v) Awareness Rally of School's Children may be organized.
- (vi) Radio Talk Show or NukkadNatak shall be organized on this campaign.
- (vii) Drawing/Slogan/Essay Competition may also be conducted in Schools, Observation Home/NariNiketans/Girls Homes etc. and top three winners of each category shall be felicitated by the DLSA.
- (viii) Medical Health Check-up Camp shall be organized in the Schools, Observation Home/NariNiketans/Girls Homes/Children Home/Shelter Home/Special Home in collaboration with the Medical Department.
- (ix) Wider and adequate publicity of this Campaign shall be ensured through Local T.V. Channel, Print & Electronic Media and Digital Platform.
- (x) News, information, photographs and Videos of the activities must also be uploaded on the Facebook Page of the DLSA on regular basis by tagging all the DLSAs and Uttarakhand SLSA.
- C. All the DLSAs have been directed that effective coordination and active participation of the following stakeholders is highly required to make this Campaign a grand success:-
- (i) District Administration;
- (ii) Police Administration and Special Juvenile Police Units;
- (iii) Social Welfare Department;
- (iv) Medical and Health Department;
- (v) School and College Administration;
- (vi) Commission for Protection of Women Rights;
- (vii) Commission for Protection of Child Rights;
- (viii) Juvenile Justice Board and Juvenile Welfare Officers;
- (ix) Child Protection Units and Child Marriage Prohibition Officer;

- (x) Child Welfare Committees.
- (xi) Child Psychologist/Psychiatrists.
- D. All the DLSAs have been directed to utilize the services of Panel Advocates, PLVs and Tehsil Legal Services Committees; strictly as per the actual need.
- E. All the DLSAs have been directed that during the aforesaid Campaign, the whole District shall be covered; especially rural areas and far-flung hilly terrains.
- F. All the DLSAs have been directed to submit a consolidated report with short compiled videos, photographs and newspaper cuttings of the aforesaid Campaign to this Authority positively by the evening of 21th June, 2024 in the enclosed proforma alongwith a brief write-up of one page.

In compliance of the above directions, reports from all the DLSAs were received.

Accordingly, a Consolidated Report has been prepared by this Authority and the same is hereunder:-
