Sealed tenders are invited for the modernization/ upgrading the mechanism of one Elevator/ lift of INDO-FUJI *make* installed at the Chief Justice Court Block of the Court & annual maintenance contract of one Elevator/ Lift of *OTIS make* installed at the Six Court Block of the Court. The elevators may be inspected & the terms and conditions of tender may be seen by the intended bidders at Management Office in High Court, Nainital on any working day during office hours from 04.04.2011 to 28.04.2011 or on our website **<http://highcourtofuttarakhand.gov.in>**. Sealed tenders should be submitted on or before 28.04.2011 by 3.00 PM and tenders will be opened at 4.00 PM on the same day.

Terms & Conditions for INDO-FUJI elevator/ lift :-

1. The Bidders shall deposit bid security for Rs.26,000/-. The bid security shall be pledged in the name of Registrar General, High Court of Uttarakhand, Nainital in the form of demand draft or fixed deposit receipt or Bankers cheque or Bank guarantee to the satisfaction of undersigned safeguarding the interest of the High Court in all respects.
2. Bid securities of the unsuccessful bidders shall be returned to them at the earliest after expiry of the final bid validity but not later than 30 days after the award of the contract by the High Court.
3. To ensure due performance of the contract, successful bidder will be required to furnish performance security which shall be 5% of the value of the contract safeguarding interest of High Court in all respect. Performance security may be furnished in the form of account payee demand draft, fixed deposit receipt from Commercial bank, Bank Guarantee in an acceptable form safeguarding High Court's interest in all respects.
4. Performance security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the suppliers/bidders including warranty obligations.
5. Bid security shall be refunded to the successful bidder on receipt of performance security.
6. Tenders submitted by the persons or firms who are not registered with Trade Tax Department shall not be considered.
7. The Court reserves right to approve or cancel any tender at any time without prior notice or assigning any reason.
8. While submitting tender, the firm should keep provision for following works that might be involved in the modernization:-
 1. Dismantling of existing controller, car operating panel, Landing button, hoist-way switches, car top junction box, car top switches, traveling cable, hoist-way wiring and other unwanted accessories.
 2. Provision of new microprocessor based ACVVVF controller.
 3. Provision of new car, operating panel with digital indicator in car cabin.
 4. Provision of new door operator with accessories.
 5. Provision of new landing button with illuminated button and digital indicator at all floor.
 6. Provision of new ACVVVF control system in door operator.
 7. Provision of new magnet switches with accessories in hoist-way and car cabin top.
 8. Provision of new hoist-way switches with accessories.
 9. Provision of new battery operated alarm bell and emergency light.
 10. Provision of new flat traveling cable with accessories.
 11. Provision of new G.R.I. Cam.
 12. Provision of new inspection box at car top.
 13. Provision of complete rewiring of the elevator with copper wires including new junction boxes and other wiring materials as required.

9. The dismantled materials shall be the property of the bidder company and the necessary credit for the same be taken into account.
10. If any extra work other than above-mentioned is needed for modernization or any work that is not needed, should be clearly mentioned in the tender.
11. All the preparatory works required (regarding construction) for the modernization should be clearly mentioned in the Tender and cost of the same should not be included, as that will be done through this office.
12. Company shall clearly submit the terms & conditions for the method of payment.
13. Company shall have to clearly specify the minimum time period required for the modernization of said lift.
14. The Company has to give free service maintenance for one year after modernization of the said elevator & will have to attend the call at its own expenses.
15. Company shall also submit an Agreement for Maintenance Contract for a period of five year after expiry of free maintenance period.
16. All disputes shall be subject to jurisdiction at Nainital only.

Terms & Conditions of OTIS elevator/lift :

1. The firms submitting tenders shall have to deposit a demand draft for Rs. 10,000/- in the name of Registrar General, High Court of Uttarakhand, Nainital, payable a Nainital as security along with tender. This shall be returnable in case tender is not accepted but this amount shall be retained as security money for the firm whose tender is accepted.
2. The firm shall have to make the maintenance immediately. In case of failure, the Registrar General shall have a right to take appropriate action including forfeiture of security.
3. The firm shall have to attend the call at its own expenses.
4. Tenders submitted by the persons or firms who are not registered with Trade Tax Department shall not be considered.
5. The Court reserves its right to cancel any tender at any time without prior notice or assigning any reason.
6. The Security amount shall be refundable after the expiry of period of A.M.C.
7. All disputes shall be subject to jurisdiction at Nainital.
